I SI Jol Kumar Mandy of Baghmundi P.S. do hereby produce accused persons (1) Arjun sing Laya, S/O Leru Sing Laya of Jilingtard, PS Baghmundi, Dist Purulia (2) Prahallad Lohar, S/O Gopal Lohar of Bareria, PS Baghmundi, Dist-Purulia to the P.S. in custody and lodged a complaint as Suo-Moto against the above noted accused persons to the effect that on 23.04.18 at 21:10 hrs acting on a source information noted in G.D. vide this P.S. G.D.E. No-997 dtd- 23.04.18 that some suspicious character assembled in Tapaban Four Point Crossing More under Baghmundi P.S, Dist-Purulia for committing an organized crime, myself along with (1) O/C Baghmundi P.S, (2) SI Biswajit Murmu (3) ASI Samir Kr. Mishar (4) C/610 Achinta Bauri (5) C/1055 Santimay Samanta, (6) JC/1207 Gopi Ballab Guin, (7) JC/449 Arun Duley, (8) JC/211 Biplab Singha all of Baghmundi P.S rushed nearby assembled place at Kalimati More by govt. vehicle JH05BC7608 vide G.D.E. No-997 Dtd-23.04.18. We approached to the P.O on foot by keeping vehicle at a distance of 500 meters away (approx) and surrounded the same quickly and surreptitiously. As it was odd hours of night and lonely place there was no local people. We heard suspicious human voice at a distance from 10/15 meters to converse among themselves in Bengali dialect. After having heard this myself along with my officer and forces challenged the suspicious character as police party and they started running helter shelter and one red colour CD Deluxe motorcycle rider fled away from the spot. But we instantly apprehended (1) Arjun sing Laya, S/O Leru Sing Laya of Jilingtard, PS Baghmundi, Dist Purulia (2) Prahallad Lohar, S/O Gopal Lohar of Bareria, PS Baghmundi, Dist-Purulia and others fled away from the spot. During search one improvised country made pipe gun loaded with one live ammunition 8 mm found in left side waist of Arjun sing Laya, and one Bhojali found left side waist of Prahallad Lohar.

On interrogation the accused persons gave their names and address as on the overleaf and stated that they assembled there for committing dacoity on Jhalda- Baghmundi pitch road during this night on any merchandise truck or from any businessmen. On demand the above noted miscreant could not produce any valid license of any competent authority in favour of possessing illegal arms and ammunition and to acquire the same. So I arrested them informing the ground of arrest and prepared seizure list of all the articles which were seized and labeled from their possession and as well as from the P.O, duly signed by the police witnesses as there was no local witnesses available there. As it was evident during our raid the accused persons assembled at a solitary place and were preparing amongst themselves with weapons found in their possession for committing dacoity on Jhalda-Baghmundi pitch road, actually committed an offence punishable U/S- 399/402 IPC and 25/27/35 Arms Act. In view of this I arrested the above noted 02 (Two) accused persons and seized the weapons from their possession by preparing seizure list on the spot duly signed by the witness and brought them to P.S at 23.45 hrs and registered this case U/S- 399/402 IPC and 25/27/35 Arms Act against the above noted two (02) accused persons as suo-moto and directed SI Biswajit Murmu to take up its investigation.
