The above name complainant begs to state as follows:

Mahato have their landed property and that the property situated at mouza Jambedia under P.S. Boro, recorded as L.R. Khatian no. 245 and 427, Plot no. 242 and 241 having an total area of 59 decimals + 59 decimals i.e. 1(One) Acres 18 decimals in all and the complainant and the said Subhas Chandra Mahato and prior to that their respective father used to posses the said and in course of possession they actually planted about 400 to 500 Sonaijhuri trees thereupon since after purchase and those threes grown well and became very valuable property.



- 2) That the complainant are possessing the property without any restrained or objection from any one and they also used the branched of those trees from various ways having perfect, right, title, interest and possession over the schedule land including those trees. On the other hand the accused persons have no manner of right, title, interest and possession over the same.
- That on the date of incident i.e. on 24/02/2018 on sudden 3) armed with lathi, Tangi, tabla, Saw, axe, criminally trespassed in the schedule plot along with other some unknown labourer and a tractor bearing registration no. WB55A-6616 upon the schedule property and have cut and remove about 70 to 80 of Sonaijhuri trees from the schedule plot, in to the schedule property of the complainant situated at mouza Jambedia, under Manbazar presently Boro. Seeing such illegal and high handed activities on the part of the accused persons the complainant along with Subhas Chandra Mahato protested them for such illegal cutting and removing those wood the complainant protested their illegal work and accordingly the accused persons slapped the complainant and also threatened if the complainant dare to protest their such act in that case they will not heisted to finish his life.

4) That the incident was report to the officer-in-charge of local P.S. and when no legal action was taken by the said Police then another complaint was lodged to the Superintendent of Police Purulia but same fate. Hence the complainant is under compelling circumstance filed this complaint before this Ld. Court under the law.
