In producing here with the arrested accd. Persons namely (1) Basudeb Mahato (24 Yrs.) S/O Rathu Mahato of Vill. Barghutua, P.S. Jhalda, Dist. Purulia (2) Manaranjan Mahato (19 Yrs.) of Vill. Silidih, P.S. Silli, Dist. Ranchi (JH) along with seized articles beg to state that today (02/04/2018) while myself accompanied with ASI Ratan Kumar Dey and forces vide Tulin OP C.C No. 282 Dtd. 02/04/18 were engaged in evening mobile duty at about 20:45 Hrs. Received a telephonic information from reliable sources that some miscreants assembled behind one abandoned Leprosy Mission on Tulin - Jargo road near Chowpad village under Jhalda P.S. being armed with deadly weapons with intend to take preparation to commit dacoity at Tulin area and were preparing themselves for the same. On receive said information myself SI Gopika Sundar Dutta with force rushed to the spot to work out the information. At about 21:05 hrs, We reached near Leprosy Mission and parked our vehicles in a safe and secret place and briefed other forces properly and guarded the area and at 21:15 hrs. found some persons assembled and were whispering among themselves. On seeing Police party they started to flee away. But after a hot chase we managed to apprehend the above noted accused persons and rest 05 (Five) others managed to flee away. On being asked the above noted accused persons disclosed their identity as noted above. After detain them I started to searched their persons in presence of Police witnesses as no public witnesses were found and seized one Bhojali length approx 18 (Eighteen) Inch. And One Iron rod length approx 4 (Four) Ft. From their possession under proper seizure list. On asked they confessed that they along with (1) Pankaj Mahato S/O Gopal Ch. Mahato (2) Chiku Mahato S/O Not known Both of Kenduadih, P.S. Jhalda, Dist. Purulia and (3) Madhu Mahato of Buribir P.S. Jhalda, Dist. Purulia (4) Sakil Khan S/O Hasim Khan (5) Bittu Khan S/O Imam Khan both of Tulin, P.S. Jhalda, Dist. Purulia also assembled there to commit dacoity at any area under Tulin and were preparing themselves for the same. Then I arrested them after maintaining all the formalities regarding arrest. As such the above noted accused persons have committed an offence u/s- 399/402 IPC. Produce the seizure articles and arrested accused persons.

I, therefore requesting you to lodge an FIR against the above noted accd. Persons and arrange for its investigation. $\dot{}$
