

4.Occurence: 04-10-1977 and 17-10-2016 at Village Ilu, P.S. Jhalda, District Purulia and within the jurisdiction of this court.

5.Offences: 420, 423, 467, 468, 471, 120-B, 506 / 34 I.P.C.

The above named complainant begs to state as

follows :-



1----That your petitioner is an illiterate and rustic poor villager and for his livelihood he used to work as a labour and use to reside for long time at Tata Jamshedpur (Jh.) for his labour work . Your petitioner has his residential house and other properties in his native village . Taking the long absence of your petitioner the accused Bhriguram Gorai in collusion with the other accused persons and the deed writer entered into a criminal conspiracy and hatched a plan to cheat him and to grab the valuable residential house of your petitioner by false personation Bhriguram Gorai , knowingly substituting him as Gunadhar Gorai (i.e. the complainant)and fraudulently get registered the residential house of your petitioner in the name of Rabi Gorai the father of accused Bhriguram Gorai on 04-10-1977 corresponding to 18th. Kartik 1384 B.S. .

2----That your petitioner believes that in collusion with the deed writer accused Bhriguram Gorai described him as Gunadhar Gorai appeared before the Sub –Register Jhalda Registry Office in place of your petitioner Gunadhar Gorai and get registered the Homestead of your petitioner in the name of the father of accused Bhriguram Gorai and deceitfully cheated / deprived the petitioner as well as the sub Registrar and the office stuffs.

3---- That it may be mentioned here that your petitioner is an illiterate man he could not able to write and sign his name . Your petitioner all along put his L.T.I every where. Your petitioner further believes and apprehends that accused Bhriguram Gorai put his Signature in place of your petitioner on the sale deed . Your petitioner never came to Jhalda Regisrty Office on 04-10-1977 and never put his signature on the sale deed . Already stated that your petitioner could not write and read as he is an illiterate person .

4----That on 17-10-2016, in the Durga Puja time your petitioner and his family members come to his native village for repair his residential house but the accused Bhriguram Gorai and the other accused persons for the first time disclosed that father of accused Bhriguram Gorai has



purchased the residential house of your petitioner and asked the petitioner and his family members to leave the place and disallowed him to open the door. At this, your petitioner and his family members protested the such conduct of the accused persons and asked them that he never execute any deed in favour of the father of accused Bhriguram Gorai or other any day or at any point of time and told the accused persons that you are cheat me, you deprive me by false personation at this, all the accused persons asked your petitioner and his family members to leave the place immediately otherwise dire consequences would follow they threatened and also threatened the petitioner that if you dare go to repair the house in that event his head would be chopped off.

5----That under such circumstances , your petitioner and his family members came back disappointed and enquired about the forged deed and applied for the certified copy of the same and after delivery of the certified copy of the same your petitioner and his family members come to know about the fraudulent and forged deed .

6----That in this way all the accused persons in collusion with each other committed the offence of criminal conspiracy, false personation, forgery, cheating and its allied offences for the wrongful gain to them and wrongful loss and deprive to the petitioner.

7----That your petitioner informed the matter to the local police station . the duty officer assured your petitioner to take legal measure against the culprits but no specific case has been started against the accused persons by the police best known to them . Finding no other alternative , your petitioner had sent a request letter to the Superintendant of Police Purulia on 21-10-2016, but it is matter of regret that nothing has been done on the part of good office.



8.----That your petitioner is a fairly aged man having no source of income. He is helpless and is in acute distress. He is not in a position to pull and conduct the case at his own cost. More over there are some technical and legal aspects involved in this case seizure, arrest etc. which also requires considerable money and machinery. For all these a police case is highly desirable.

It is prayed that your Honour may be graciously pleased to direct the I. C . Jhalda Police Station to investigate the case , treating the same as F.I.R. as contemplated U/S/ 156 (3) Cr. P.c. in accordance with law .

And for which act of kindness as in duty bound , your petitioner shall ever pray .
