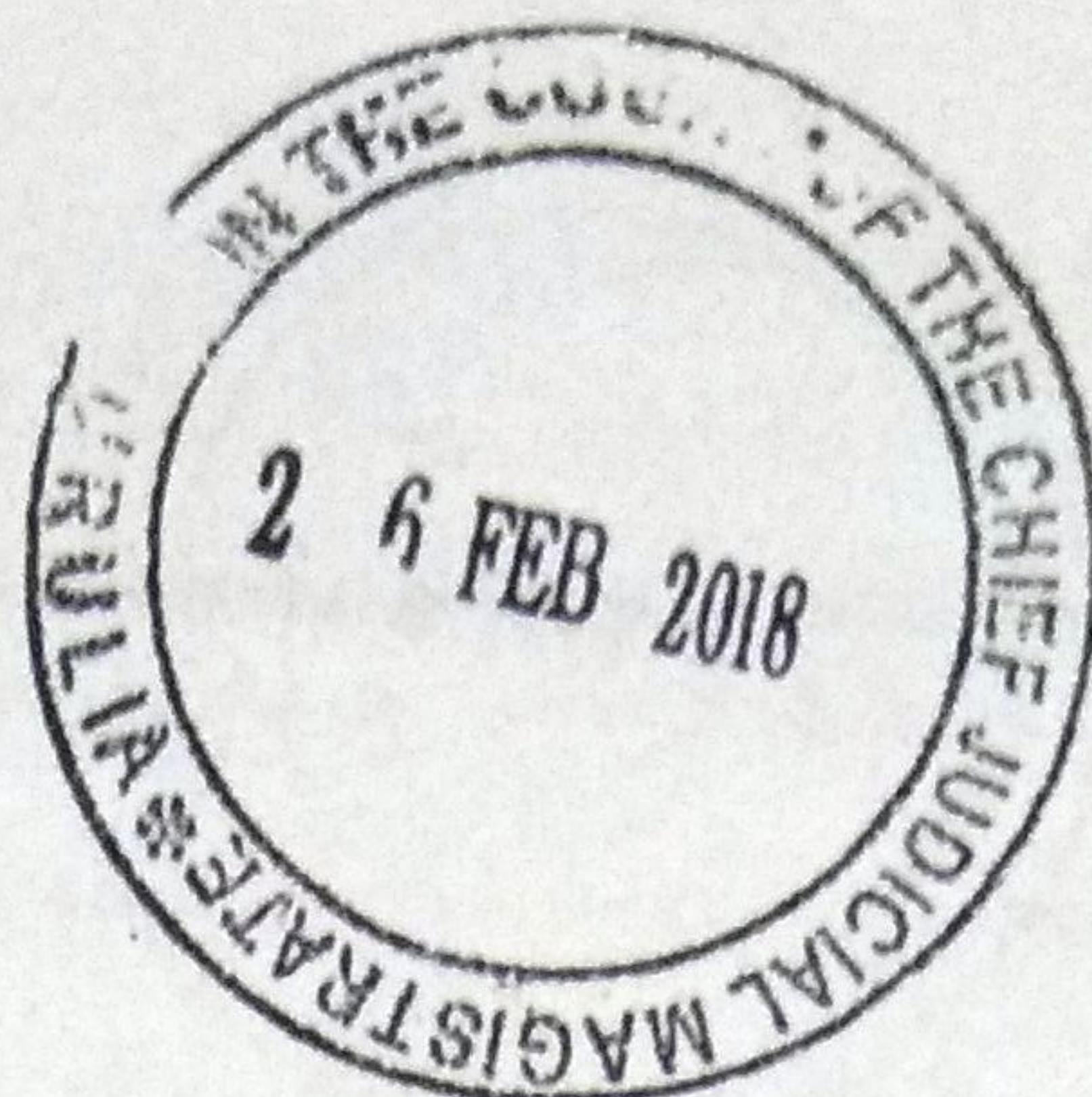

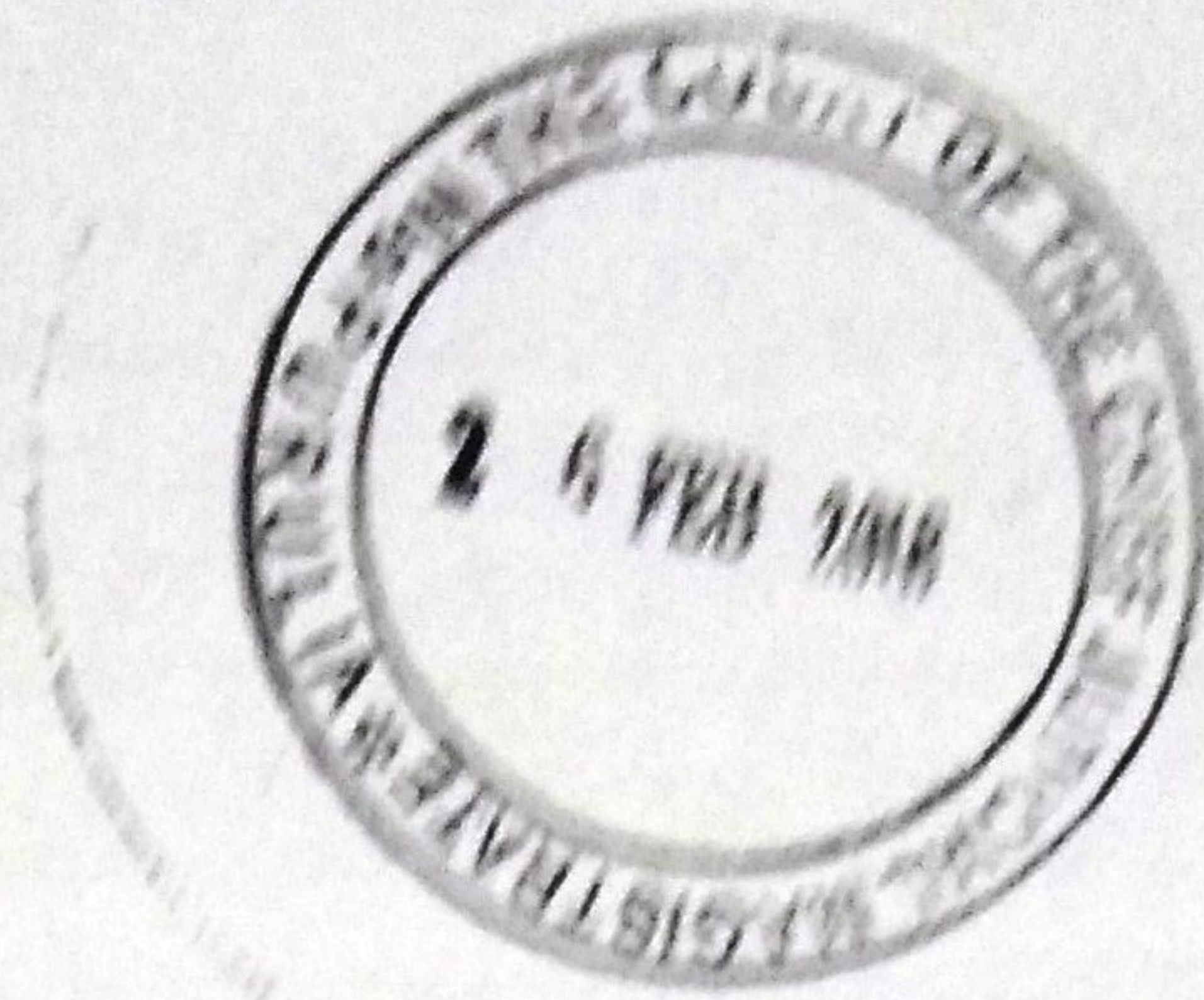
The Complainant above named:-

Most respectfully begs to state :-

1. That the Complainant is the permanent resident of village Bandulahar, P.O.-Mahatomara, P.S.-Jhalda Dist.-Purulia (W.B.) which is under Jurisdiction of this Court.
2. That the property bearing Mouza - Garia, Thana - Jhalda , J.L.no.-20, Sabek plot no.-13- 1476 Originally belongs to my great -grand father Late Kalinath Mahato after death of my grand father Kirtan Mahato and others Co-sharers my grand father Kirtan Mahato inherited the said property and possessed the same , and after death of Kirtan Mahato my father by way of inheritance is the actual Owner of the said property and possessed the same cystik now.
3. That be it mentioned here that on the said properties , Sabek plot no.-48 area 1 Acre 13 decimals on the said Gora land some old and valuable trees are there on which w is situated at one Kilometre from the residing the petitioner .
4. That on 10.9.2017 at about 10.00 A.M. Morning the Petitioner / Complainant came to know that Haladhar Majhi S/o Prahalad Majhi and their brothers and No.1 to 4 sold out two old Karam Trees value of Rs. 2,000,00 (Two lakhs )to one Udin Ansari son of Lt.Amar Ansari and no.5 cutted the two Kram Trees with the help of same others.

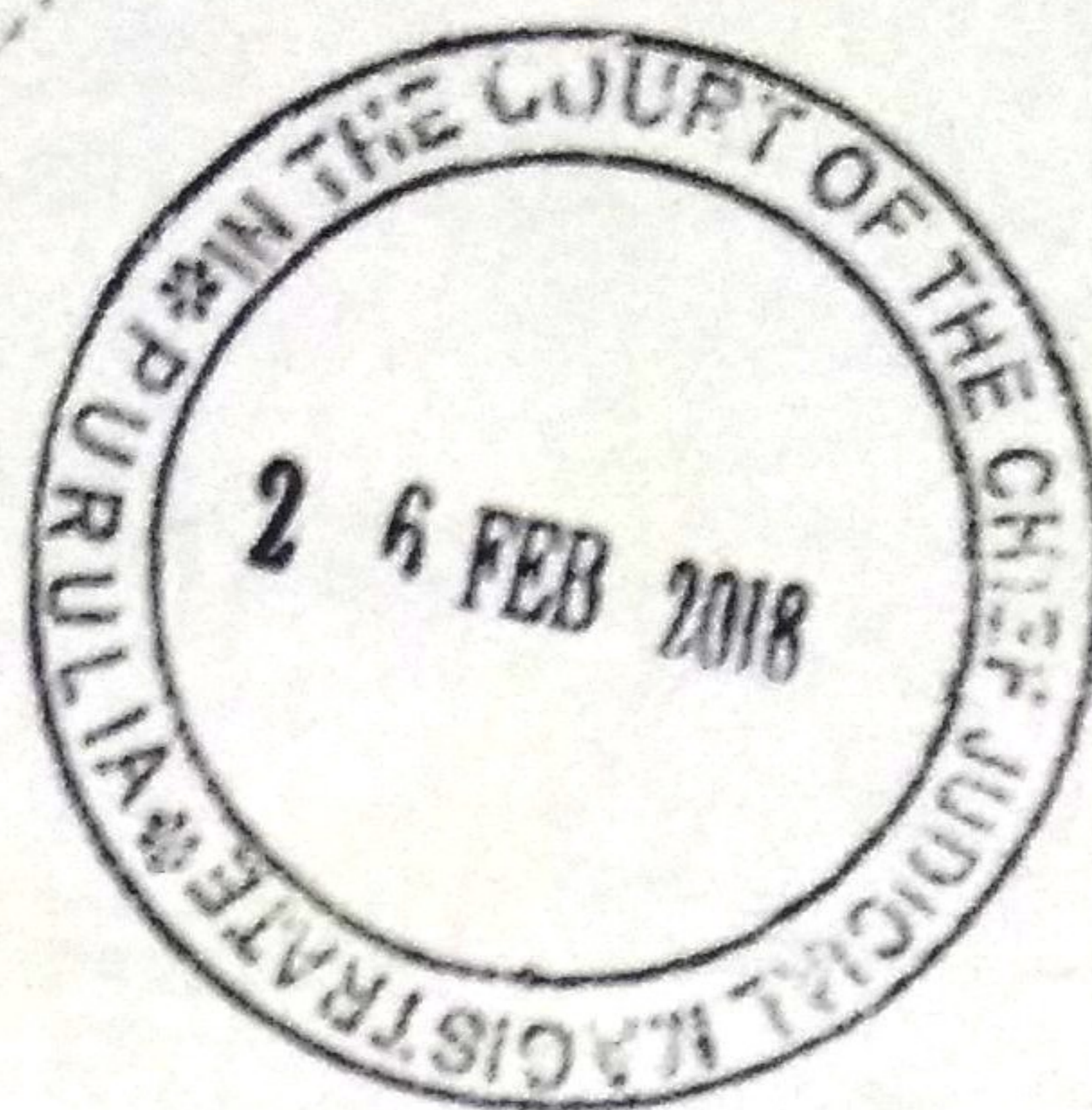
5. That heard after news petitioner /complainant went to the spot and saw that three persons viz. 1) Gour Majhi 11) Radhu Majhi 111) Rahina Majhi all are sons of Late Nital Majhi of the same village were cutted the two Karam trees with the help of saw and one accused no.-1 to 5 were standing there and gave direction for speedy work .

6. That the petitioner went to Haladhar Majhi and his brothers and requested them no to do that wrongful unjustified and illegal work. But all and persons 1 to 5 didnot pay any heed to the petitioners request. Eventall were having abuses to the petitioner and did not entered near the trees . They forcibly resisted the petitioner and threatened that if the petitioner not leave the place he will be murdered along with his family . On that situation the petitioner had no option but to leave the place.

Then the accused persons cutted the two Karam trees and loded the same by tractor and the away .

7. That the petitioner then went to the Jhalda P.S. and informed the matter verbally and by written complain but the police officer of Jhalda P.S. did not take any step regarding the said matter and lastly after same days they advised the petitioner to go to comit

8. That after that the petitioner informed the matter to Panchayet and villagers but no any solution was made out .

That On 04/01/2018 petitioner lodged a written Complaint regarding the said incident before Superintendent of Police Purulia (Xerox copy of the said complaint is enclosed with this petition ) but till now no response from S.P.office , Purulia and no action has taken from Jhalda P.S.regarding the same and as such the petitioner has no option but to file the said Misc. petition before the Ld. Court.

It is therefore prayed that your Honour may graciously be pleased to direct the police of Jhalda P.S. to treat this petition of Complaint as a F.I.R. Under the provisions of 156(3) of the Cr.P.C. and to investigation in respect of the alleged incident.
