In producing here with 02 (Two) arrested accused persons namely (i) Suman Goswami (27 Yrs) S/O-Dhaneswar Goswami of Vill- Dewandera, PS-Jhalda, Dist-Purulia and (ii) accd. Goutam Kandu @ Barababu (24 Yrs.) S/O Sasadhar Kandu of Vill- Dangal, PS- Kotshila, Dist- Purulia under arrest with seized articles i.e the following article; (i) 24 (Twenty Four) sealed bottles of ELTURES-T cough syrup 100 ml. each (Codine Phosphate & Triprolidine Hydrocloride Syrup) of Elder PHARMACEUTICALS Ltd. Company, Batch No.- SD17020 Exp date- APR 2019 containing one Carton (ii) One Motor Cycle having bearing no. WB56J 1024 (Splendar Pro.), Chasis no. MBLHA10A9EHC6024 which were found from their possession.

I do hereby lodged this written complaint to the effect that on 23.04.18 at 17:05 Hrs, I received a telephonic source information that two persons mentioned above and with connivance of others unknown are selling illegal drugs near at Jhalda Block more. I informed the matter to I/C Jhalda PS and as per his direction I, ASI Basudeb Acharya along with C/538- Dayamoy Mahato, C/1031- Pankaj Patra, H.G/1634- Gopal Majhi left PS at 17:25 Hrs for Jhalda Block More to work out the information with Govt. Vehicle vide C.C No-1197/18 Dtd-23.04.18 & Vide GDE No-954 Dtd-23.04.18. As soon as we reached near at Jhalda Block More at about 17:45 Hours, we suddenly saw four (04) persons started running having seen the Police vehicle and we, keeping in mind the source information also started running after them and after a little chase, two persons got apprehended and rest two(02) were at large. On interrogation they disclosed their identity as mentioned above and they also disclosed that the others those were pissed off namely 1. Chinmoy Tewari S/O Binod Tewari of Vill- Dangal, Ps- Kotshila, Dist- Purulia and Lalchand Kumar S/O Not known of Vill- Beladih, Ps- Kotshila, Dist-Purulia. They also disclosed that they are the entire Cough Syrup business partner and since long they have been continuing this business and today they gathered for the purpose of selling drugs to the local youth customers. On being searched found one black Colour plastic hand bag containing 24 (Twenty Four) sealed bottles of ELTURES-T cough syrup 100 ml. each (Codine Phosphate & Triprolidine Hydrocloride Syrup) of Elder PHARMACEUTICALS Ltd. Company, Batch No.- SD17020 Exp date- APR 20119 containing one Carton and (ii) One Motor Cycle having bearing no. WB56J 1024 (Splendar Pro.), chasis no. MBLHA10A9EHC6024. On demand they failed to produce any valid documents/license in respect of keeping the said drugs and sale the same. So I seized the same from their possession under proper seizure list duly signed by the police witnesses as there was no other local witnesses available there right that moment and as well as signed by the apprehended person and also prepared label with seal of one bottle of ELTURES-T cough syrup as sample taking among seized bottles. I arrested 02 (Two) accused persons namely Suman Goswami (27 Yrs) S/O- Dhaneswar Goswami of Vill- Dewandera, PS-Jhalda, Dist-Purulia and accd. Goutam Kandu @ Barababu (24 Yrs.) S/O Sasadhar Kandu of Vill- Dangal, PS- Kotshila, Dist- Purulia for violating the Sec-27 of Drugs & Cosmetics Act-1940 and after maintaining all formalities I informed him the ground of arrest. Houses 1. Chinmoy Tewari S/O Binod Tewari of Vill- Dangal, Ps- Kotshila, Dist- Purulia and Lalchand Kumar S/O Not known of Vill- Beladih, Ps-Kotshila, Dist- Purulia could not be traced during further raid except SL No-4 due to want of identifier and the accused as well.

On return to PS along with Accd. persons and all seized articles and put the Accd. Persons in the Lock UP after maintaining all formalities and seized articles kept in PS Malkhana. So, I pray before you to start a case against accused person namely (i) Suman Goswami (27 Yrs) S/O- Dhaneswar Goswami of Vill- Dewandera, PS- Jhalda, Dist-Purulia (ii) Goutam Kandu @ Barababu (24 Yrs.) S/O Sasadhar Kandu of Vill- Dangal, PS- Kotshila, Dist- Purulia (iii) Chinmoy Tewari S/O Binod Tewari of Vill- Dangal, Ps- Kotshila, Dist- Purulia (iv) Lalchand Kumar S/O Not known of Vill- Beladih, Ps- Kotshila, Dist- Purulia as per law and arrange for its investigation under proper section of law.
