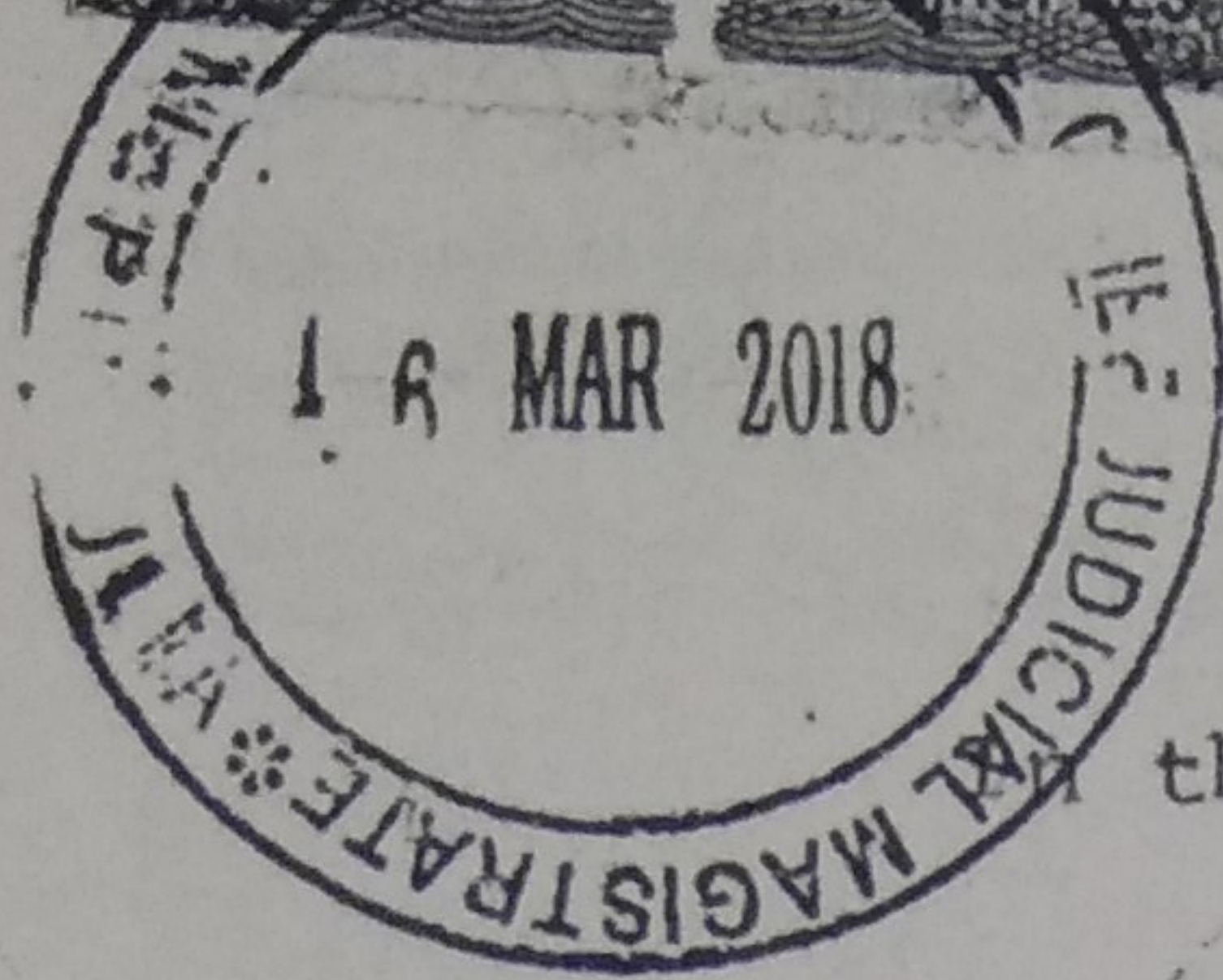

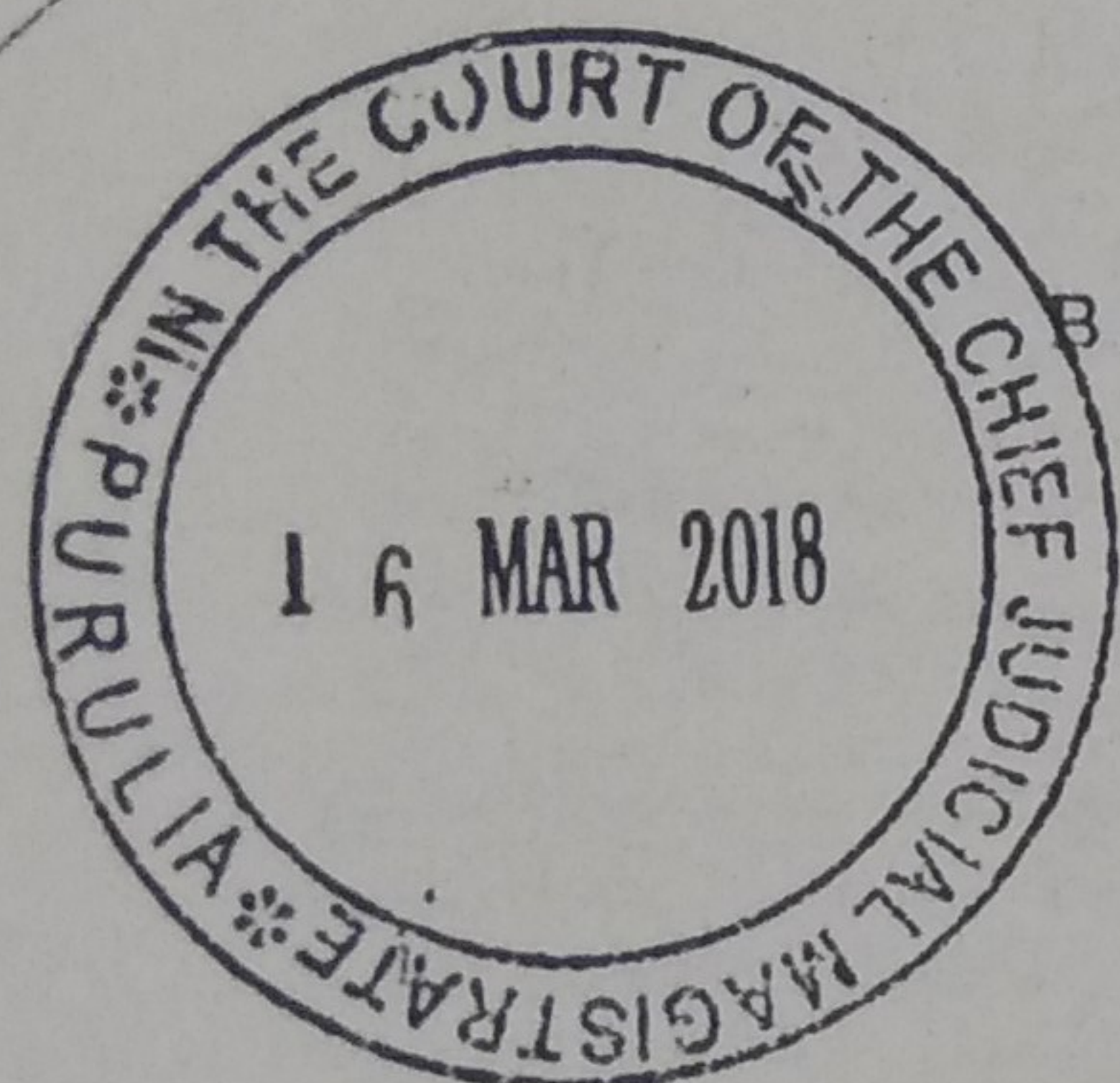

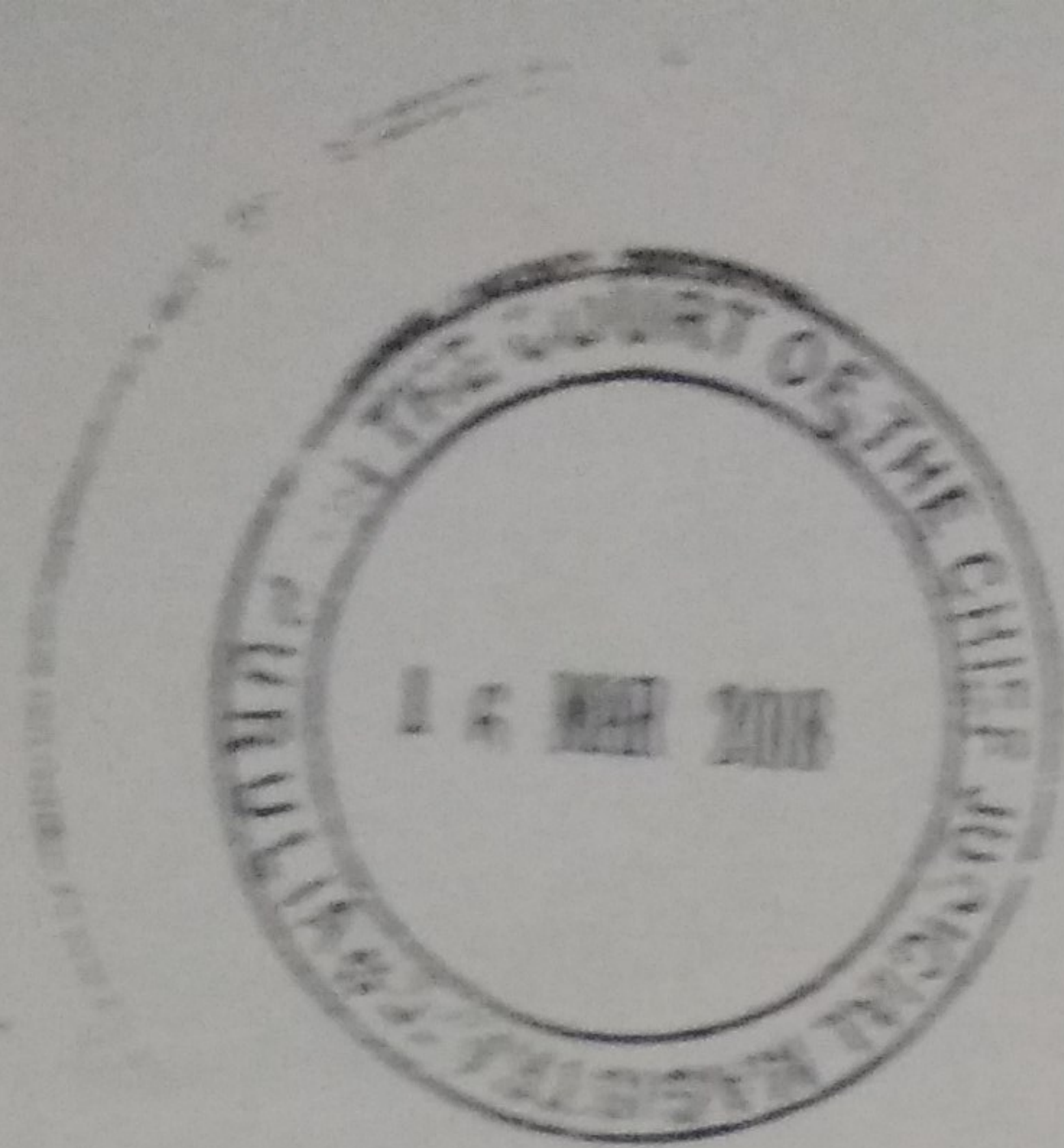

The above-named complainant begs to state as follows:-

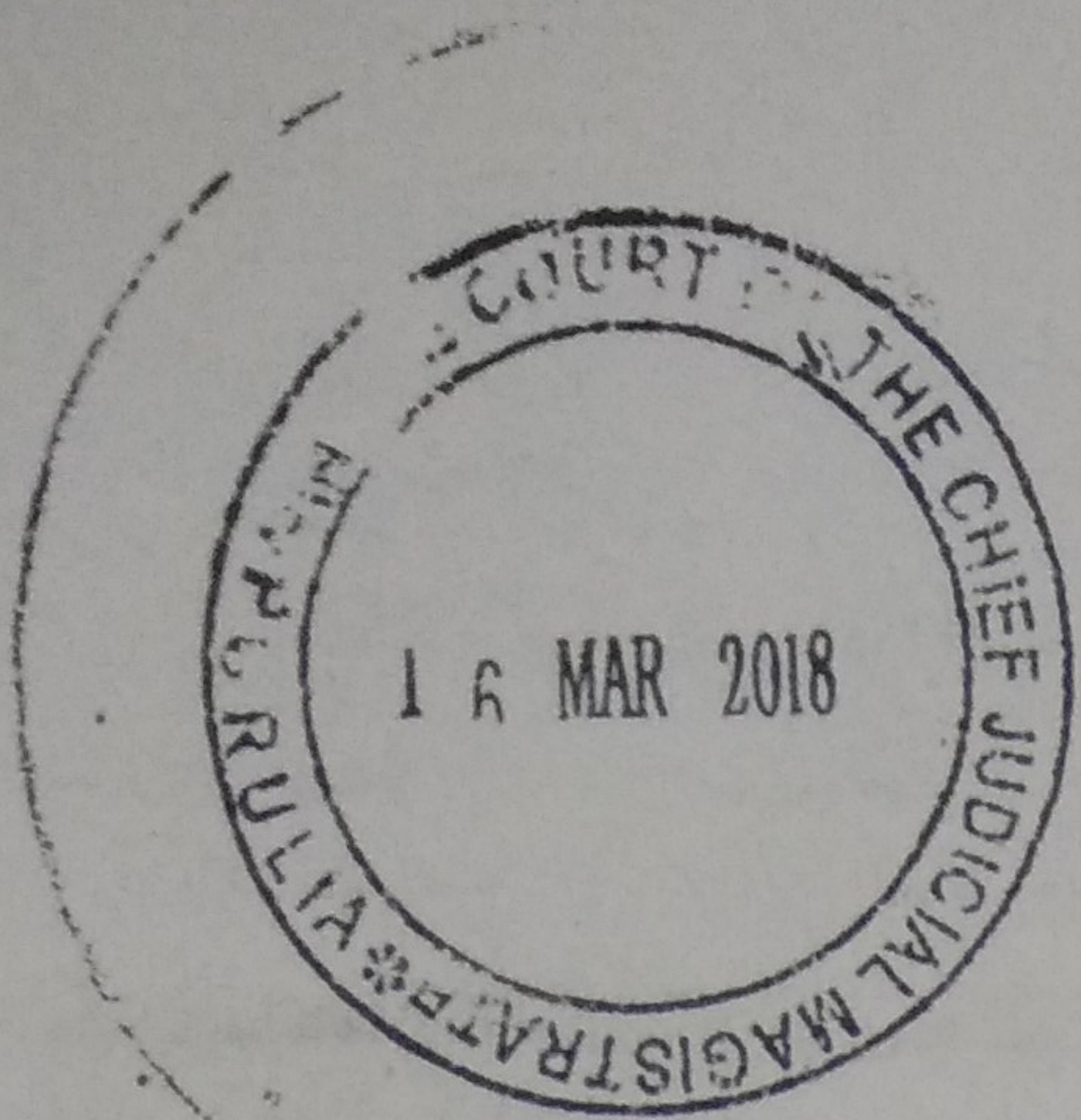
Most respectfully sheweth:-

1.---That the complainant is the resident of village-Paprahurum, P.S.Jhalda, Dist.Purulia and accused persons No.1 to 7 are also the residents of village-Paprahurum P.S.Jhalda, Dist.Purulia.

2.---That the Schedule property of this complainant pection is situated at mouza-Paprahurum, P.S.Jhalda, Dist.Purulia within the jurisdiction of this ld court.

3.---That the schedule property is the ancestral property of the Complainant which has been recorded in the name of the father of the complainant Pashupati Singh, in the Revisional record of Rights said Pashupati Singh possess^{ed} the schedule land by producing Rabi crops such as Raher-Kalai, Biri, Kurthi etc. till his death. After the death of Pashupati Singh. Present Complainant came into actual physical possession of the schedule land. Present complainant also possessing the schedule land like his father by producing Raher-Kalai, Biri, Kurthi etc. like previous years present complainant cultivated the land grown Raher-Kalai, and Planted 50 Mango, 60 Man and 45 Segun Seeds and grown the same. But on 20-07-2017 at about 9.30 A.M. present accused persons No.1 to 7 making unlawful assemblie with criminal conspiracy with each with greivous weapons, such as Lathi, Tappi, Parra, Iron -rod, Gaiti, Kodal etc. Firstly they breaking the wall of the boundary all about 5 feet length and 4 feet hxx height there after they trespassed the schedule land and started cut the baby tree there after

taken away the said baby tree to their house and mischief the Raheer-Kalai from the schedule land .Present complainant tried to resist the accused persons but they threatened to cause murder for which the complt. rendered helpless. Present Witnesses have ~~been~~ seen the incident and tried to resist them .Complainant ~~start~~ ^{shouted} for help for which many village people came near the place of occurrence, Seeing the gathering of the village people accused persons fled away from the place of occurrence.

4.---That aforesaid incident was informed to the local Police Station of Jhalda P.S. But Jhalda P.S. has not ~~started~~ started police C_ase against the above named accused persons .Then the complainant informed the above incident to the Superintendent of Police, Purulia but the police of Jhalda P.S. still quite mum and has not stated any Police case against the accused persons. Hence the complainant is bound to filed the present case for proper relief.

Considering the above facts and circumstances, it is therefore prayed that your honour may graciously be pleased to send this complaint petition to Jhalda Police Station treating the petition as F.I.R. Under Section 156(3) Cr.P.C.

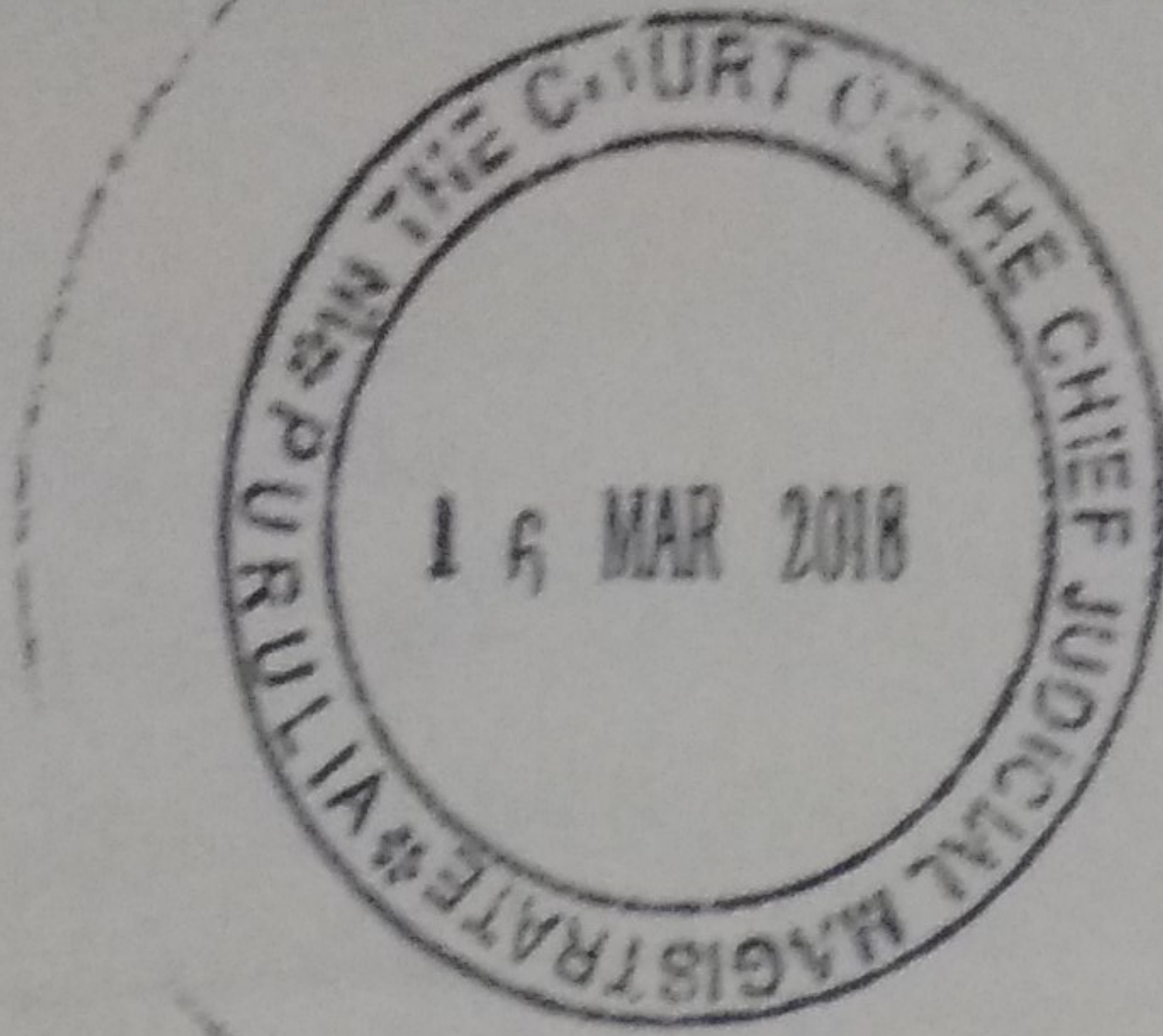
