4.---That aforesaid incident was informed to the local Police Station of Jhalda P.S.But Jhalda P.S. has not stated started police Case against the above named accused persons. Then the complainant informed the above incident to the Superintendent of Police, Purulia but the police of Jhalda P.S. still quite mum and has not stateed any Police case against the accused persons. Hence the complainant is bound to filed the present case for proper relief.


