The above named complainant begs to state as follows:-


Most respectfully begs to state:-

1. That the complainant is a permanent resident of R/o- Vill + P.O- Tulin, P.S- Jhalda, District- Purulia, and within the jurisdiction of this Ld. Court.
2. That a land situated at Pargana- Jhalda, Mouza- Uhupiri, P.S- Jhalda, C.S Khata No. 2, C.S Plot No. 720, R.S Khata No. 15, R.S Plot No. 919 measuring an area about 45 cubits out of 1.34 acre, is recorded in the name of the father of the complainant namely Anil Kumar Chandra and some others and they are the rightful owner of the land and after the death of Anil Kumar Chandra, the complainant and his brothers inherited the said property.
3. That some wrongdoers namely 1. Sudhir Chandra Mahato, S/o- Late Naran Mahato, 2. Kedarnath Mahato, S/o- Late Naran Mahato, 3. Ranjit Mahato, S/o- Late Naran Mahato, 4. Rupchand Mahato, S/o- Late Naran Mahato and 5. Kailash Mahato, S/o- Late Naran Mahato, all are resident of village- Uhupiri, P.O- Tulin, P.S- Jhalda, Dist- Purulia, i.e the accused persons no. 1 to 5, by hatching a criminal conspiracy in collusion with some other and by using muscles power forcefully took possession of the said land.
4. That thereafter seeing no other alternative the rightful owners of the said land being law abiding citizens of this country filed a title suit for declaration of title and recovery of possession before the Civil Judge, Junior Division, Purulia and after hearing, the Ld. Court was pleased to pass judgment and decree in favour of the father of the complainant and some other owners of the said land.
5. That after the judgment and decree passed by the Ld. Court the above named accused persons had no regard to court of law and had not vacated the land, accordingly seeing no other alternative the owners of the land filed an execution case and in due

- procedure the owners of the said land anyhow able to took possession of the land with the help of police and Nazir of District Judge's Court, Purulia.
6. That the complainant and other owners of the land used to cultivate on the said land and produced paddy and others, but the above named accused persons came to the land in the month of November, 2017 with weapons in their hands and started to abuse the owners of the land in filthy languages and threatened them to plough up the field unless they will not be given possession of the land or to execute bond for deliver the possession of the land, and on deny the above named accused persons assaulted the owners and threatened them to commit murder and also threatened to taking forcible possession of the land and at the time of leaving they stolen away certain paddy from the land.
 7. That under the circumstances set forth above, it is crystal clear that the above named accused persons by hatching a criminal conspiracy, with common intention and object illegally trespassed into the land of the complainant and others, and started to abuse the complainant and other owners of the land in filthy languages and threatened them to plough up the field unless they will not be given possession of the land or to execute bond for deliver the possession of the land, i. e committed extortion, and on deny the above named accused persons assaulted the owners and threatened them to commit murder and also threatened to taking forcible possession of the land and at the time of leaving they stolen away certain paddy from the land and thereby committed various offences which are liable to be punished in accordance with law
 8. That the matter was duly intimated to Jhalda P.S, but they refused to take any action.
 9. That thereafter seeing no other alternative the matter had been reported to the S.P. Purulia, on 18/01/2018, but no positive response from his end. Hence this petition.
 10. The Xerox copy of the information given to the Superintendent of Police is enclosed herewith.



It is therefore prayed that your Honour will be graciously pleased to send this petition to O/C Jhalda P.S. to treat this petition as an FIR as contemplated u/s 156(3) Cr. P.C. and to start a case in accordance with law and to unearth the wrong doers so that they can face their trial in the court of law.
