Sir,

In producing here with the accused person namely Bishnu Singh Sardar @ Sarju Mudi (35) S/o-Late Debu Singh Sardar @ Ramakeshor of Banglatard-Dangal, PS-Kotshila, Dist-Purulia, Previously village Narayanpur, PS-Joypur, Dist-Purulia & Golkunda, PS-Purulia (M), Dist-Purulia brought under arrest along with seized articles as per seizure list i.e. one improvised country made one shooter Iron made pipe gun length approx 10 inches having Iron butt, body, barrel, trigger, firing pin etc and one round live ammunition, I, ASI Manoj Kr Das of Joypur PS do hereby lodged a written complaint against the above noted accused person to the effect that on 06/04/2018 at 23:35 hrs, duty officer of Joypur PS, ASI Tarun Kr Bhui received a secret source information that one person was moving on Joypur-Pundag pitch road near Sashi more under Joypur PS in suspicious manner. After receiving such information duty officers noted the fact in GD vide Joypur PS GDE No- 255/18 dated 06/04/18 and after discussion with IC Joypur PS inform me to work out the information. As such myself along with force C/-05 Biswajit Mahapatra, C/-473 Manoranjan Singh Babu & C/886 Ajit Kr Mahato immediately left to work out the information vide Joypur PS CC No- 870/18 dated 06/04/18 and on 07/04/2018 at 00:05 hrs we reached near to Sashi more and keeping our Govt. Vehicle No- WB56C-8982 in a safe distance we slowly moved to the information place and found said person was standing under a tree nearby for any crime upon the ongoing vehicle on Joypur-Pundag pitch road at any time and we able to apprehended him and on being suspicion I search the said person and found that one improvised country made one shooter Iron made pipe gun loaded with one round live cartridge was kept in his left side of the waist under is full pant. On demand of papers he failed to produce any papers / documents in support of carrying / possessing such fire arms. On interrogation he disclosed his identity as noted above and made incoherent statement in respect of his presence at that place and also the purpose of possessing said fire arms and ammunition. It is reasonable to believe he choose the said along place pre-plainly to commit any grievous offence against vehicle etc. So finding no any other alternative way and after observing all the formalities I seized the said fire arms and ammunition under a proper seizure list in presence of witnesses as well as accused person and make over one copy of the seizure list to him and he put his signature as token of acknowledgement and also labeled the same by me. I tried my label best to singed the public witnesses but as time is dead in night and in alone place and far distance from villages so none present there, So I unable to put signature any public witnesses on the seizure list. Hence I arrested him issuing memo of arrest as he is liable for prosecution u/s 25 (1) (a) Arms Act.

During interrogation he also confessed that previously he was arrested in Arsha PS Murder Case and Purulia Town PS Dacoity Case.

I therefore pray that a specific case may kindly be started against the accused person namely Bishnu Singh Sardar @ Sarju Mudi (35) S/o-Late Debu Singh Sardar @ Ramakeshor of Banglatard-Dangal, PS-Kotshila, Dist-Purulia, Previously village Narayanpur, PS-Joypur, Dist-Purulia & Golkunda, PS-Purulia (M), Dist-Purulia, under proper section of law and arrange its regular investigation.
