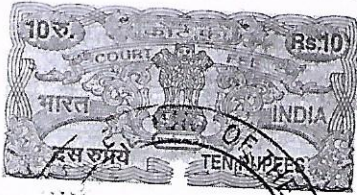

Most respectfully begs to submit as follows:-

1. That the informant is aged man, and he is the father of the injured Sri Ranjoy Kumar and the accused are the co villagers of the informant.
2. That, be it mention here that on 23.2.18 at about 12.00 noon, the informant and his son was working at their own land, at that time one Hagru Kumar, Tulsi Kumar and Samala Kumar, came to the land of the informant armed with katari and latni and started abusing the informant and his son when the informant protested against such illegal act of the accused then the accused. Hagru Kumar assaulted the Ranjoy Kumar with a Katari on his head, with a intention to kill him, the injured then and there fell on the ground in a pool of blood when the informant protested, Tulsi Kumar assaulted him with a lathi, hearing the commossion village people came and save the life of informant and his son.
3. That then and there the local people had taken the complainant and his son to Kotshila Rural Hospital for treatment and after primary treatment the doctor of said hospital referred the complainant and his son to Purulia Sadar Hospital for better treatment.
