In producing herewith the accused persons namely (i) Prasenjit Kumar @ Prasna (20 Yrs) S/O-panbhunath Kumar of Belyadih, PS- Kotshila, Dist- Purulia and ii) Radha Raman Kumar @ Kudra (20 Yrs) S/O-Gopal Kumar of Vill Matkuma, P.S- Kotshila, Dist- Purulia, under arrest and seized articles (1) One white coloured plastic "Basta" loaded with 22 Kg 700 gm Cannabis/Ganja (2) 03 Envelope containing 100 gm. Each of loose Cannabis/ Ganja which have been collected from the said basta as sample & 3) One Bajaj Pulsar Red & black coloured motor cycle having Regn. No- WB 56K/1352 under proper seizure list sealed and labeled, duly signed by the witnesses and accused persons. I, SI Palash Kr. Barik, O/C Kotshila PS, do hereby lodged complaint as suo-motu against the above noted 02 (Two) accused persons for committing an offence punishable U/S- 20 (b) (i)/29 NDPS Act. 1985.

Today (15.04.18) at 18:15 hrs received a reliable source information that 02 (Two) drug peddler namely (i) Prasenjit Kumar @ Prasna (20 Yrs) S/O- Sambhunath Kumar of Belyadih, PS- Kotshila, Dist-Puruliaand ii) Radha Raman Kumar @ Kudra (20 Yrs) S/O- Gopal Kumar of Vill Matkuma, P.S-Kotshila, Dist-Purulia riding on a Red & black coloured Bajaj Pulsar motor cycle are coming from Pundag side through VIP More towords Kotshila PS area on Pundag-Kotshila road.

The source also informed that they were carrying one white plastic "Basta" containing Cannabis/Ganja on the middle of the driver & pillion rider on that motor cycle. I noted the fact vide Kotshila PS GDE No- 679/18, dated- 15.04.18 and informed the matter to CI Sadar, Purulia & SDPO, Jhalda, and other superior officers of Purulia district. As per their direction myself along with my source, C/623 Rantmath Gorai and C/1391 Jayanta Kr Panda (vide CC No- 750/18, dated – 15.04.18) left for VIP More on Pundag-Kotshila road to work out the information by Govt. vehicle having Regd. No- WB 55A/3868 also carried seal, gala, match box, Envelop, candle, paper etc.

Today i.e 15.04.2018 at 19:05 hrs reached near VIP more within a visible distance of place of assembly of suspect and got down from the vehicle, kept the vehicle in a hiding place, we ambushed ourselves at bushy area with proper briefing. Kept watch at the road extended between Pundag side and Kotshila. At about 19:25 hrs we noticed that one motor cycle is coming from Pundag side towards Kotshila with excessive speed. We gave signal to stop the motorcycle but they willfully ignored the signal and tried to flee away. Some how we could able to apprehend the motorcycle with the driver & pillion rider at VIP more with one white "Basta". Being asked the disclosed their identity as (i) Prasenjit Kumar @ Prasna (20 Yrs) S/O- Sambhunath Kumar of Beladih, PS- Kotshila, Dist- Purulia, ii) Radha Raman Kumar @ Kudra (20 Yrs) S/O- Gopal Kumar of Vill Matkuma, P.S- Kotshila, Dist- Purulia. On interrogation, they confessed that the said "basta" contained Canabis/ Ganja. They also stated that they carrying the same for selling at Kotshila, Jhalda and its surrounding area. Informed the matter to CI Sadar, Purulia, SDPO, Jhalda, Purulia. Thereater, I issued a notice to both accused persons asking them whether they are willing to be searched by me in presence of an Executive magistrate or, a Gazetted officer. In reply of the notice both detained persons gave their willingness in writing to be searched in presence of an Executive Magistrate, accordingly I informed to CI (S), Purulia for his presence and to SDO, Jhalda to depute an Executive Magistrate with a request for search and seizure as per provision of section 50 of NDPS act. Then started waiting for the arrival of Executive Magistrate and CI (S) Purulia. Meanwhile, we searched for public witnesses with the help of accompanied force. After a while two public witnesses namely (1) Jaiprakash Gorai @ Manoj, S/O- Nitai Gorai of vill- Chitmu, PS- Kotshila, Dist- Purulia and (2) Thakurdas Gorai, S/O- Dinabondhu Gorai, of vill- Chitmu, PS- Kotshila, Dist- Purulia became ready to assist us in conducting search and seizure and weighting the article.

At 20.25 hrs Sri Dipak Mukhopadhaya, WBPS (Exe), BDO Jhalda II (Depute by SDO Jhalda, Executive Magistrate) and Sri Sumohan RoyChoudhary, CI (S) Purulia arrived at VIP More. Then I asked the detained persons in writing to search our selves. Accordingly they searched thoroughly but found nothing objectionable. They declared this in writing. I prepared a "Nil" sezure list.

Then I asked the public witnesses whether they have any weighing machine or balance. If they have whether they are ready to weigh the cannabis (Ganja). Then Jaiprakash Gorai @ Manoj, S/O- Nitai Gorai of vill- Chitmu, PS- Kotshila, Dist- Purulia replied in writing and weighed the Cannabis (Ganja). After weighing it is found that white "Basta" (Marked as 'A') is contained with 22 Kg 700 gm. He gave a certificate regarding the result of weighing of the Cannabis (Ganja). Then I took three sample each contained with 100 gms Cannabis (Ganja) for taking follow up action. I seized, sealed, leveled the white "Basta" as 'A' and three sample packets as A1, A2, A3 and the motorcycle bearing Regn. No- WB 56K/1352 under proper seizure list duly signed by the witnesses.

On demand they could not produce any documents for the said Cannabis (Ganja). Accordingly I arrested them I briefed them the ground for which they were arrested. I also asked them whether they were willing to inform any one regarding their arrest. They replied negatively. I issued Arrest memo and inspection memo. The entire search, seizure, labeling and arrest were done in presence of Sri Dipak Mukhopadhaya WBPS (Exe) BDO Jhalda II and Sri Sumohan RoyChoudhary CI (S) Purulia.

So I started Kotshila PS Case No- 45/18, Dtd- 15.04.18, U/S- 20(b) (i)/29 NDPS Act 1985, as Suo-motu against the accused persons namely (i) Prasenjit Kumar @ Prasna (20 Yrs) S/O- Sambhunath Kumar of Beladih, PS- Kotshila, Dist- Purulia, ii) Radha Raman Kumar @ Kudra (20 Yrs) S/O- Gopal Kumar of Vill Matkuma, P.S- Kotshila, Dist-Purulia and directed SI Sasthipada Jhariat of Kotshila PS for its investigation.
