During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) pieces of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 2) Electric Fan - 06 nos.
- 3) Water Pump - 01 no.
- 4) Freezer - 01 no.
- 5) Color TV - 01 no.
