The complainant beg to state:-

- 1) That the complainant is the permanent resident of village Bohara, p.o.-Bohara, p.s.-Para, Dist-Purulia and accused person is also inhabitant of some address.
- 2) That complainant is vegetable seller and also do cultivation to earn his living.

3) That at present Tarapada Lohar earn his livelihood by selling vegetable in local market within the para p.s. and run his family of his, his wife, and his son.

4) That on 17/01/2018 complainant was collecting ^{straw and} ~~or~~ ^{ex} paddy collecting and making bundle with straw of tract and storing in the form of " palci ".

5.) That on 17/01/2018 at about 3 p.m. after washing cloth's when complainant wife brought wash clothes in a bucket ,she saw a bull of neighbour namely (Lakhan Lohar's) which she know for last 3 month, was eeting the paddy, stored in bagkept in side her house.

6) That bull was strong enough to frightened his wife, so she called him to save her.

7) That I brought a stick from myfence and drag away the bull by saying, "Hat, Hat, Hat,"

8) That I made ^{them} complaint before the owner of bull . accused of bull and said, be alert other wise for loss of my eater paddy I will go to police concern which I said to accused per and his wife.

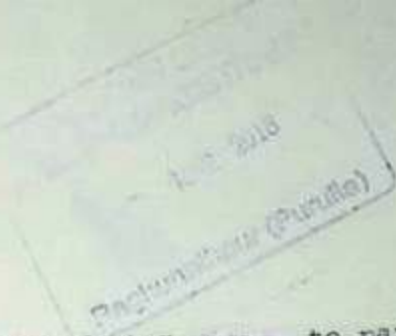
9) when I came back immediately after informing them then within 2 minutes accused and his wife came with bamboo stick spoke felthy language about my,my father,mother and fore fath and as saulted, my wife with 3 to 4 times with bamboo sticks chest, head and on back.

10) That I tried to ^{save} her, I also got assault in both my h After getting asault my wife was unconscious and they threa us to kill me and my wife, my son was also present, I said son don't come to us,

11) That after as saulting, they took ~~ammuzed~~ away the bamb sticks that accused person's had brought.

12) That about 7'00p.m. when she came to conscious, her ch was paining, could not walk properly I took her in "Thela " para B.P.H.C.

13) That about 7:30 when doctor came to para B.P.H.C. emergency ward he checked and wrote medication and advised me to refer the case to purulia hospital for serious patient.

14) Then on next day complainant went to purulia Hospital and admitted there in 12 am on dated 18/1/2018 and was admitted there fore 2 days.

15) That my wife is still unfit as pain in lower back and in chest, due to previous assault, and for her unfit illness, no one is responsible other than above accused person.

16) That due to treatment of my wife I could not write FIR before 25/1/2018.

17) That on 25/1/2018 I went to para P.S. to file FIR but they refused to take and hence on 29/1/2018 I sent Regd post to para P.S. and to Superintendent of police. till today no action against the accused person is taken and concern officer took from complainant ~~ix xaker and xaxxxxx~~ the original medical treatment paper.

It is therefore prayed your honour to accept the misc petition u/s 156(3) of Cr.p.c.
