arrangement was damage installation of the incoming wire and tap 2 (two) piece of wire from incoming terminal point of energy meter by which electricity directly flow to his house without energy registration in W.B.S.E.C.L energy meter.

From the above by passing system he uses the following electrical equipments (i) Ceiling fan 08 (eight) was each 60 watt (ii) Colour TV - 02 (two) no each 100 watt (iii) Fridge 02 (two) each 120 watt (iv) Tube light 10 (ten) was each 20 watt (v) C.F.L Lamp - 05 (five) was each 9 watt. out of which I seized the energy meter with 02 (two) core Pvc cable 25 (twenty five) meter approx. seizure list was prepared at the site and accused person refuse to sign. The inspection team left the premises at 01.30 PM on 04.04.2018. The accused person has committed an offence u/s 135 (a) & (b) of the electricity Act, 2003 Subsequently electricity (Amendment) Act 2007,

you are requested to take cognizance of this complaint & treat it as F.I.R and action may be taken as per rule.
