

An application u/s 156 (3) Cr.P.C. on behalf of the petitioner above named;

MOST RESPECTFULLY SHEWETH-

- 1. That, the complainant was married with accused No.1 under Special Marriage Act, subsequently social marriage formalities were performed on 01/03/2016 corresponding to 17th Falgun.
- 2. That, at the time of marriage complainant's father made bounty of Rs 1 lakh cash, 10 bhoris ornaments made of gold, divand, almirah, dressing table and other furniture and utensils.
- 3. That, after social marriage complainant had been to her matrimonial home and rituals of "Bouvat" was performed there at a lodge 2 K.M. away from complainant's matrimonial home.
- 4. That, since arrival at matrimonial house all the accused persons started to inflict torture upon the complainant both ways mentally and physically, they used to assault the complainant, and they were even not providing food to the complainant, because the accused persons were not satisfied with the gifted items given by complainant's father, they demanded further Rs 5 lakh from complainant's father. But complainant's father was unable to meet up the demand of the accused persons because he had to incur all expenses for complainant's marriage, as such torture was continued upon the complainant.
- 5. That, complainant stayed at her matrimonial home for 2 months and 21 days, then on 22nd May 2016 all the

accused persons called complainant's parents at complainant's matrimonial home and then complainant was led to leave her matrimonial house with her parents on the pretext that accused persons would go to Mumbai.

- 6. That, all the accused persons returned from Mumbai just after 7 days at complainant's matrimonial home, but they never came at complainant's father's house to bring her back.
- 7. That, complainant and her parents several times requested the accused persons to bring her back, but they did not pay any heed to that.
- 8. That, lastly on 25th December 2017 all the accused persons came at complainant's father's house at Village-Pandui, within P.S. Puncha and insisted the complainant to give divorce to her husband, but she was not agree, then all the accused persons assaulted her severely, and threatened her that if she refuses then she would be killed.
- 9. That, on 25-12-2017 complainant went to Puncha P.S. and lodged her written complainant there stating the entire matter. But police of Puncha P.S. did nothing in this matter.
- 10. That, then on 29/01/2018 the complainant went to the office of the Superintendant of Police at Purulia and again lodged written complaint there mentioning about the incident and also about filling of written complaint on 25/12/2017 at Puncha P.S. But this time as well police did nothing.
- 11. That, due to the above mentioned reasons and without having any other alternative your petitioner is filling this complaint before this Ld. Court of Law. And your petitioner is not in a position to continue the case at her own cost, apart from that investigation through police is required.
