



Most respectfully beg to state :-

1.... That on 12.2.2018 at about 8 P.M. I am the complainant was returning from Purulia while he reached near Arabinda High School at Durku, the all accused persons, who are known to the complainant 'Gheroud' confined the complainant and demanded with threat mood Rs. 10,000/- from the complainant to give them immediately, which the complainant denied, then, at that moment all accused persons assaulted the complainant forcibly by fists and blows snatched his Samsung Mobile bearing Sim No. 9002932770, a cash of Rs. - 20,000/- sale money of his shop, one golden chain weighing about 1 (one) Bhori (value Rs. 30,000/-) from the complainant with a threatening the complainant not to disclose this facts to other or police otherwise they will commit murder the complainant. The complainant narrated the incident to Noren Mahato ~~then~~ and Sitaram Mahato Paramanik but at their fear the complainant could not inform the matter to Police till 22.2.2018. On 23.2.2018 the complainant lodged complain against the accused to O/C Purulia (M) P.S. Po lice assured to investigate the same but did nothing then the complainant informed the matter to S.P. Purulia on 28.2.18 but still the S.P. also did not take any step so, the complainant compelled to file this complain before your Honour.
