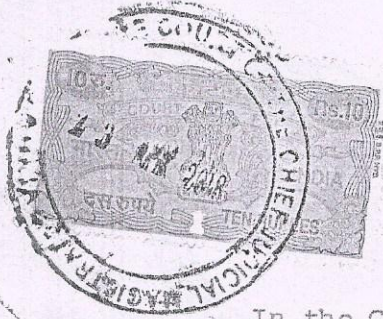

The complainant above named begs to state as follows:-

1. That the father of the complainant namely Anil Rajowar have purchased the R.S. plot no. 1523 area 10 decimals out of it 3 decimals on the southern side of the plot and R.S. plot no. 1522<sup>M</sup> area 15 decimals out of it 3 decimals southern side of the plot under R.S. khatian no. 42 of mouza Bongabari under p.s. Purulia(M) from one Jhagra Rajowar by a regd sale deed dated 18.6.2002 After purchase the complainant has constructed pacca boundary walls surrounding ~~ix~~ his aforesaid purchased land.
2. That on the date of occurrence i.e, on 28.1.2018 at about 8 A.M. all the accused persons named above being armed with deadly weapons Lathi, Tangi, Sabal etc, forming an unlawful assembly illegally and forcibly entered in the

in the aforesaid land of the complainant. and they started to damage the aforesaid boundary walls, of the complainant with help of Sabal and in this way they damaged the boundary wall of the complainant. The complainant sustained loss of Rs. <sup>41 10,000/-</sup> ~~10,000/-~~. The complainant and witnesses raised objection against the illegal activities of the accused person but they threatened the complainant in a dire consequences. The accused persons became angry and they started to assault the complainant by fist and blows and they forcibly took away sum of Rs, 1200/= from the pocket of the complainant. The witnesses named about saw the incident and the matter was also reported to them.

3. That the complainant has reported the matter to the O/C Purulia(M) p.s. on the same day but the police of Purulia(M) p.s. did not take any steps against the accused persons and accordingly the complainant reported the matter to S.P. Purulia on 13.3.2018 but till today the police of Purulia(M) p.s. did not take any action against the accused person, so the complainant has been compelled to take shelter before the Ld. Court.

4. That the complainant is a poor man and there is question of source and seizure as such police is required for the ends of justice.
