Respected Sir,

I, Smt. Tapasi Mukherjee w/o Sri Ramprasad Mukherjee, a permanent resident of K.K.Roy Lane, Dulmi Nadiha, P.O. Dulmi Nadiha, P.S. Purulia (W.B), like to draw your kind attention to the affect that I am the legally married wife of Mr. Ramprasad Mukherje to whom I was given in an Inter caste Marriage in the year 1997 and since 2002 we have been living as husband and wife having two minor children in a house gifted to me by my father. My marriage was a negotiated one without any demand from the side of my husband which was not liked by my mother in law Smt Shankari Mukherjee, W/O Late Shibaram Mukherjee of Chattani Para Purulia, and my three sister in laws (1) Dipti Chattaraj, W/O Late Ardhendu Chattaraj, Saratsen Compound, Purulia (2) Bakul Chatterjee, W/O Dilip Chatterjee, Nimtar, Purulia (3) Rama Chattaraj, W/O Pradip Chattaraj, Station Para, Purulia. After marriage I had been to my matrimonial house and started to live as husband and wife in a joint family consisting of my husband and mother in law in a rent house at Dulmi Nadiha. From the very inception of my stepping in my matrimonial home, my mother in law and sister in laws started various mental and physical torture, cruelty and harassment upon me on the ground, of dowry and insufficient households' articles. My mother in law and her three daughters openly spoke out that I must bring Rs. 2, 00,000 from my father otherwise I would have no place in their family but my husband did not like the illegal demand of my mother in law and others and over the issue of fresh demand made my mother in law and her daughters, frequent quarrel and hot altercation occurred between my husband on one side and my mother in law and sister in laws on the other. Off and on my mother in law and my sister in laws stop my meal and physically oppressed me and my husband as all of them reside at the same P.S. and nearer to us. Considering the social status as tutor and to purchase family peace my husband shifted to my own house at K.K.Roy Lane and started to live separately far away from my mother in law and her daughters still then they time to time come to our house jointly started to physically assault me and my minor children and for that I was compelled to inform the matter before the local P.S. Vide Purulia (T) P.S.G.D.E No. 105 Dated 03/11/2004. Being a devoted Hindu wife bears those torture, cruelty and harassment on the hope that my mother in law and my sister in laws would mend themselves and would be normal towards us

but my hope were never materialized. Day by day volume of mental torture and harassments were intensified by my mother in law and her daughters which is beyond description remotely over telephone.

It may be mentioned here that on and from 14<sup>th</sup> April 2018, with the help of some antisocial my mother in law and sister in laws continuously threatened us with dire consequence and spoke out that they would taught us a good lesson and also told that they would finish us from the world and in fact on 19/04/2018, at about 9.30 p.m. all on a sudden being accompanied by some unknown antisocial my mother in law and three sister in laws came to our house. When I protested the illegal and forceful activities of the strangers and my sister in laws Dipti Chattaraj, Bakul Chattaraj, and Rama Chattaraj started to humiliate me with abusing slang languages. I shouted for help saying "Bachao, Bachao", then the miscreants hurriedly left the place with a threatening that they would finish us from the world forever. I along with my family members are feeling unsafe even loss of life at the instance of the afore miscreants.

Under such circumstances, it is prayed that you may be kind enough to take appropriate legal action against the above named miscreants and others in accordance with law.
