



That in order to fulfill their oblique motive da well as to take regenge of previous grudge Accd. persons at the relevant point of time deshed the bastu wall of the complt with a Bolero 4 wheeler being No. JH02 R-4418 duly owned by the accd. persons just to cause damaged the Bastu wall. Heard the heavy sound owing to illegal act of the accd. persons complt having been awaken from sleep rushed to the spot in which Accd persons langh at the complt and on protest made by complt Accd. persons grew furious in Red teath & claws and started assaulting the complt with a Knife duly held by Mrinal Chatterjee simlarly Kunal Chatterjee also assaulted the complt with the help of iron rod intornt of bastu of the complt.

- 4. That both the accd. persons with an intention to finish the life of the complt .tried to assault the complt on his head chest hut any how complt had a narrow escape from being, muscled are the hand of the accd persons. Needless to say both the accd. persons also pressed the neck of the complt to finish his life by threttling, complt. sustained we bleeding injury due to the assault from the accd. persons.
  - 5. That complt cried for help in which witness came to the P.O. in which finding no other alternative Accd.persons fled away from the P.O. with a holding that they will finish the life of the complt at any opportune moment.
  - 6. That there after rushed to Raghunathpur P.S. A2 A.M. on 1.2.18 with a written complanant against the Accd. persons but P.S. authority advised the complt. to under go medical treatement for the injury caused by the accd. persons with an assurance that appropriate action to be taken against the accd. persons.
  - 7. That having been discharged from Raghunathpur State

    General Hospital complt. visited Raghunathpur P.S. since No
    action was taken by the P.S. but P.S. concern moved their view
    and advised the complt to take alternative remedy. as such



your complt sent his grievances to the s.P. Purulia through post on 19-2-2018 but till date no action has beautaken against the accd. persons.

- 8. That the accd. persons who are very much inimical and rough in nature also holding out in the locality that no one can do anything since they are having high handed action. Needless to say accd. persons are loitering in the locality with their hand held high inspite of committing crime upon the complt.
- 9. That finding no other alternative taking you the best recourse for his redressat assault, the offence committed by the accd. persons.

It is therefore prayed that O/C Raghunathpur P.S. may kindly be directed to investigate into the matter after treating the instant petition as F.I.R. as per provision u/s. 156(3) Cr.P.C.
