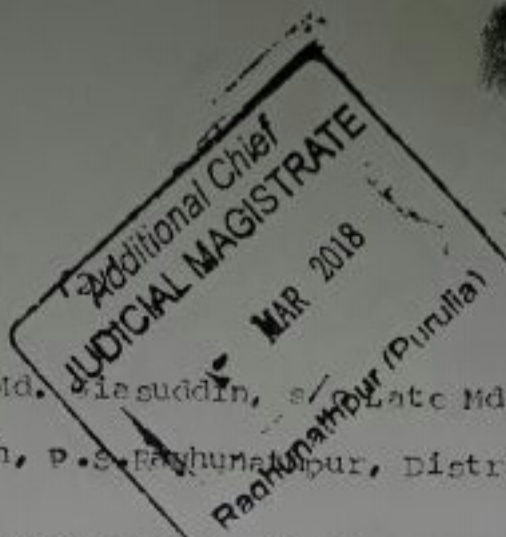

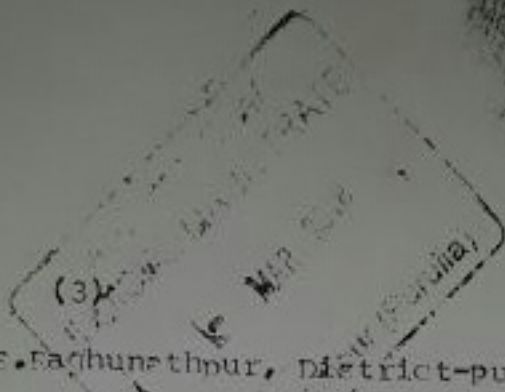

The humble petition of the complainant
Most respectfully sheweth :-

1. That the complainant being the resident of Sankra(B) in Para P.S. got married with Salima Bibi, D/o Sajahan Dorji of village/p.o. Nutandih, p.s. Radhanathpur, District Purulia under your honour's jurisdiction about 8 years back and that the complainant as per the wish of his wife aforesaid wanted to build a residential house at Nutandih after purchasing a land at Nutandih from a lawful owner thereof.
2. That on being aware of complainant's desire the accd. of this case, being the husband of complainant's wife's elder sister, met the complainant in the 1st part of October, 2017 and expressed to sell his own 03 dec. of land out of 06 dec. on plot No. 3140 under Narira Mouze

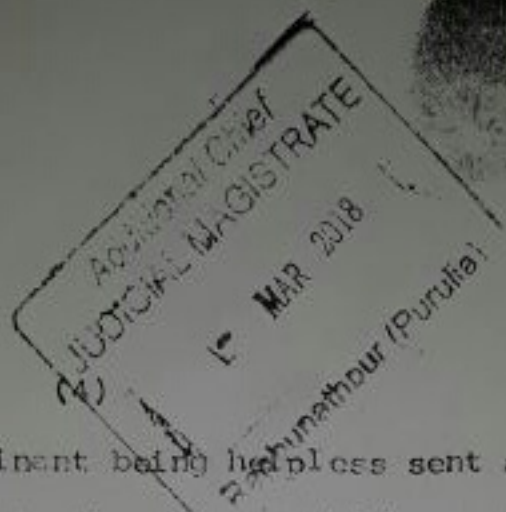

in P.S. Raghunathpur, District-Purnia to which the complainant, believing the accd. being his 'Bhairabhai', agreed and accordingly on 30/10/2017 the complainant paid cash of Rs. 30,000/- as full and entire consideration money of said 03 dec. of land in good faith in presence of the local witnesses including the present witness as well as the elected member of the Nutandih G.P. who figure as witness No.2 and a written instrument was prepared upon one Govt. Non Judicial stamp on the very date, i.e., on 30/10/17 to that effect and the accused also put his signature upon such instrument in presence of the witnesses acknowledging the receipt of entire consideration money of the said land. It is pertinent to mention that when the accused sold 03 dec. of land, he showed the demarcation of such land and also assured the complainant to get the said land registered with a couple of months and the accused also told the complainant to make construction upon the said demarcated land for residential purpose. Hence the complainant on good faith built up a room with veranda with asbestos roof by spending huge amount of Rs. 1,00,000/- to the knowledge ~~and~~ of the accused and witnesses and public at large.

3. That the complainant since after payment of such consideration money repeatedly requested the accused to get the said land registered in his favour but to no result, rather on 31/01/18 the accd. threatened the complainant not to disturb him further and accordingly

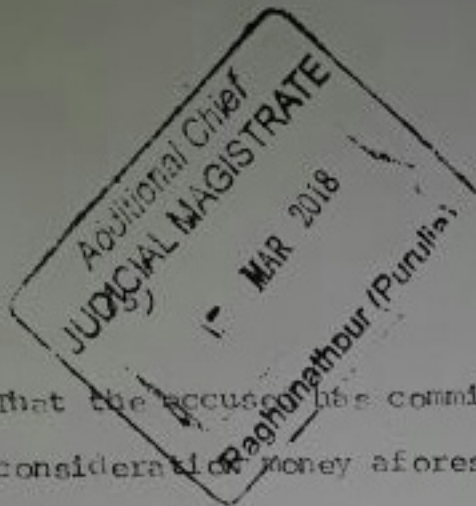

the complainant being helpless sent a legal Notice on 01/02/2018 to the accused which was duly received by the accused on 02/02/2018. The accd. is so demeritate that he did not care to reply to that legal Notice dated 01/02/18.

4. That the complainant thereafter lodged a written F.I.R. before Raghunathpur P.S. concerned detailing everything and enclosing the supply of xerox copies of such written instrument dated 30/10/2017 and the Legal Notice dated 01/02/18 but it is unfortunate that although the Raghunathpur P.S. assured to take legal action against the accd. ^{and that} when the police did not take any step in the matter, the complainant reported the same to S.P. Purulia by speed post on 18/02/2018 but it is painful that neither Raghunathpur P.S. ^{nor} the S.P. Purulia did take any step till date. Hence the complainant having no other alternative has filed this complaint petition after due compliance thereof before the Ld. court.

5. That the complainant now thinks that the accd. had induced the complainant to part with the money as payment of sale of land not owned by him and issued bogus receipt, the intention being dishonest it amounts to cheating.

6. That the accused has committed the offence by taking the consideration money aforesaid for the personal gain and for cheating.

7. That the complainant is very poor and that he is not in a position to bear the day to day court expenses. Hence he has come before this court for relief.

It is therefore prayed that the O/C, Raghunathpur P.S. may kindly be directed to take necessary action against the accused treating the complaint u/s 156(3) Cr.P.C. as F.I.R.
