Sub : Prayer for lodging FIR against accd. (1) Kristapada Gorain (48 yrs) S/O - Barun Gorain of Vill. - Ichhar, PS-Santaldih Dist- Purulia U/S 46A (c) B.E. Act 1909.

Sir,
In producing herewith arrested accused (1) Kristapada Gorain (48 yrs) S/O - Barun Gorain of Vill. - Ichhar, PS-Santaldih Dist- Purulia along with seizure - list and seized items as described below, I beg to state that on 12.04.18 at about 15.45 hrs received a source information to the effect that the country liquor have been kept at Ichhar in the house of above noted accd. illegally with an object to sale. I convey the matter to duty officer SI Anower Hossain Khan. He has diarized the information under Santaldih I/C BCW GDE No- 118 dated- 12.04.18 and as per order of O.C Santaldih I/C (BCW), PS -Santaldih I along with force left for Ichhar to work out the information with the govt. supplied kits box containing while cloth, sealing wax, seal, papers, carbons, candles etc. I had been to the house of Kristapada Gorain at Ichhar, P.S. Santaldih at about 16:05 hours. Seeing police some unknown persons in front of the house of Kristapada Gorain fled away.

However, I could detain one among him and asked about his identity. He revealed his name and identify as above and as well as informed also that he gather the country spirit for selling and he was the owner of the said house. However, I along with said accd. started a search inside the house of Kristapada Gorain and found the following item in the said house.

- 1) 20 (Twenty) bottles 80UP country spirit (Dil se) each bottles containing 600 ML market value of each being in total approx Rs. 700/ - (Seven hundred only)
- 01 (one) bottle of 600 ML taken out of the above as sample packet, labeled and sealed with sealing wax.

I interrogated him about the purpose of the stocking and possessing of the liquor said to be country spirit. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List between 16:15 hrs and 16.35 hrs & took up one bottle of each brand as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, the C.S illegally without any valid papers for the purpose of selling in his house has prima-facie been made out and for the interest of proper investigation. I arrested the above accused at 16.36 hrs accordingly.

Therefore, I pray before you to start a case under proper section of law against the said accused Kristapada Gorain (48 yrs) S/O Barun Gorain of Vill. - Ichhar, PS-Santaldih Dist- Purulia.
