In producing here with one arrested accused person namely Chitta Bouri (66 Yrs.) S/O Lt. Ratan Bouri of Vill- Sarberia PS- Adra Dist- Purulia along with following seized articles viz-

- 1) 15 bottles (in sealed condition) DIL KHUSH 80 up country spirit, 600-ml each bottle and value-Rs-35 of each bottle.
- 2) Sale proceed of Rs.-70/-
- 3) Nine pieces of plastic glass.

I ASI Giridhari Roy of Adra P.S. do here by lodged a complaint against accused namely Chitta Bouri (66 Yrs.) S/O Lt. Ratan Bouri of Vill- Sarberia PS- Adra Dist- Purulia to the effect that on 07.05.18 at about 18:05 hrs. in course of my anti crime evening mobile duty I received a telephonic information from a reliable source that one namely Chitta Bouri (66 Yrs.) S/O Lt. Ratan Bouri of Vill- Sarberia PS- Adra Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with JC/411 Pinku Saha & JC/572 Ajoy Giri rushed to the spot for raid by Govt. vehicle. At about 18:55 hrs. myself along with force reached at Sarberia village and hold raid in the cowshed of Chitta Bouri (Sarberia Village) and found that said Chitta Bouri sealing liquor at his own cowshed and seeing the Police party some person fled away and said Chitta Bouri to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing/selling the same, So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accused person and available witnesses.


