2. That the accd. person forcefully encroached the entrance path of the complainant and upon protesting a dispute arise between the complainant and the accd. persons.
3. That the complainant inform about the land dispute to the local police station i.e. O/C Adra P.S. but the police instead of acting on the lodged complaint issued notice against the complainant and his elder brother U/S 107 Cr.P.C.
4. That while returning from the S.D.E.M. court on dtd.: 08-01-18 after attending before the Ld. S.D.E.M. court at about 4 P.M. when the complainant is about to enter into his house the accd. persons attack the complainant and started to abuse the complainant in most filthy language and assault the complainant with iron rod, lathi and by fist and blows without listening to the complainant and threatening the complainant of dire consequences.
5. That the complainant tried to escape from their hold but all in vain and thereafter hearing the cry of the complainant the two persons namely Dipek Tiwari and Bhairab Bouri came running towards the complainant and rescued the complainant from the accd. persons.
6. That moreover the accd. persons namely Tushar Kanti Dubey snatched Rs. 2000/- (Rupees Two thousand) only from the pocket of the complainant while other two accd. continuously beat the complainant.
7. That the complainant went to Adra P.S. for lodging diary against the accd. persons but the police concern refuse to take the complaint.
8. That on dtd. 10-01-18 the complainant send the diary to the O/C Adra P.S. through the registered post and after waiting for 26 day without getting any relief from the O/C Adra P.S. reported the matter to the S.P. by Regd. post on dtd. 05-02-18.

9. That one months period has been passed but neither the O/c Adra P.S. nor any police concern had taken any step, in deed not taken any action on the complaint made by the complainant for which ~~made~~ by the complainant for which the complainant have been compelled however to file this complaint before your Honour.

10. That the witnesses ~~as~~ saw the occurrence and the complainant will be able to prove his case. The incident is cognizable in nature and investigation by the police is required to be done, the complainant has no means to prosecute the case on his own ~~fund~~.

Under the circumstances it is prayed that your Honour may kindly be pleased to admit this complainant and officer-in-charge of Adra P.S. be directed to cause investigation of the occurrence and submit report before your Honour U/S 156(3) Cr.P.C. ~~and should treat this application as P.M.~~ and this petition may kindly be treated as F.M.R.
