

I SI Biswajit Murmu, S/O- Sri Bhagbat Charan Murmu of Baghmundi P.S, Dist-Purulia do hereby lodge a complaint as suomoto against the arrested accd. Person Joydeb Gorai@Ashu (22 yrs), S/O-Durga Charan Gorai of Vill-Nalapar Toal of Pathardih, P.O-Patahrdih, P.S-Baghmundi, Dist-Purulia to the effect that today on 26.05.18 at about 15:05 hrs in course of my mobile duty at PS area, received a telephonic information from my source that one tractor was carrying stone illegally from Dulgubera, P.S-Baghmundi, accordingly myself along with forces rushed to the spot at Dulgubera Netaji Statue More and found one tractor was coming towards Dulgubera Village Road Side. I intercepted the tractor and found that the tractor having bearing registration number WB-81/0679 was tagged with a trolley loaded with various size of stone. On being asked the driver reveled his identity as Joydeb Gorai@Ashu (22 yrs), S/O-Durga Charan Gorai of Vill-Nalapar Toal of Pathardih, P.O-Patahrdih, P.S-Baghmundi, Dist-Purulia but on demand, he failed to produce any documents of the vehicle and he confessed that he lifted the stone from the side of Blue Lake of Dulgubera which is not a registered mine and he lifted stone from the place only to escape from the Govt. revenue and hence he could not produce any challan. He also failed to produce any identity proof even D/L and there is every ground to believe that he procured the tractor and the trolley either in fraud means or by means of theft. Hence, I seized the tractor Blue Colour Sonalika Tractor with trolley bearing Model No.-0147RX, Registration No.-WB-81/0679, Eng. No.-31021L531517240F5, Chasis No.- DZVSU521843S3 being loaded with stone under proper seizure list duly sign by the witnesses, also arrested the accd. driver and after seizure observing all the formalities regarding arrest as per the guidelines of Apex Court of India, N.H.R.C & W.B.H.R.C. As the punishment of the offence he committed is less than 7 years yet I arrested him for the purpose of proper investigation and to ensure his presence in the Ld. Court as his identity could not be verified. I issue checked list.

It is therefore pray before you to start a specific case U/S- 379/411 IPC and section 21(4) of the Mines and Minerals (Regulation and Development) Act 1957 against Joydeb Gorai@Ashu (22 yrs), S/O-Durga Charan Gorai of Vill-Nalapar Toal of Pathardih, P.O-Patahrdih, P.S-Baghmundi, Dist-Purulia and arrange for its investigation.
