Most respectfully begs to state:-

- 1. That the complainant is the schedule tribe and the accused persons are the other caste other than S/T and they are the resident of same village and they are known to each other.
- 2. That on 24.3.2018 at about 7 a.m. morning when the complainant's minor son Sahebram Besra and complainant's brother Bhutang Besra were returning from the pond after meeting their nature's call on the Kuli road on previous grudge the accused persons having weapons raised on their hands them and forbade them to proceed and started to abuse minor Sahebram Besra and Bhutang Besra in filthy languages insulted them by uttering 'Chhoto jat' and attacked them.
- 3. That Bhutang Besra protested them when accused
 Ajit Mahato and Joyanta Mahato started assoulting upon
 Bhutang Besra by lathi causing injuries.
- 4. That thereafter all the accused personf forcibly cought minor Sahebram Besra and tried him and took him by dragging to words Sonaijuri village and released Bhutang Besra.
- 5. That immediately injured Bhutang Besra rushed to house and informed about the incident. At once





and other villagers rushed towards and found minor Sahebwan Besra intied condition and akea faund that with a tree
with multiple bleeding injuries and also found that his
hand broken. On asking injured narrated the incident that
all accused persons jointly assoulted him by lathi. Apart
from that accused Ajit Mahato and Arjun Mahato broke his
left hand by assaulting by lathi and all accused persons
left presuming that injured Sahebram has expired.

- 6. That the complainant with the help of others brought the injured Sahebram and caused admitted injured to Bans-garh Health Centre for his treatment.
- 7. That the all accused persons have lowered the respect of the complainant and the dignity of ST member has been damaged in the society which is offence in the eye of law.
- 8. That the complainant lodged the complain before O.C. Balarampur P.S. regarding the incident dated 24.3.18 against the all accused persons but O.C. Balarampur P.S. neither started any case nor investigate s the same. The matter has been informed to S.P.Purulia also on 6.4.18 but no result.
- 9. That the complainant is the schedule tribe and accused being other caste have brutally assaulted minor
