

Most respectfully begs to state That on 18.02.2018 elder brother of the complainant namely Mantu Thakur S/O. Lt. Ganesh Thakur left for Dhanbad from his residential house at Ramadhin Bagan, P.O. & P.S. TELCO, Jamshedpur, District – East Singbhum along with his driver i.e. the witness no.2 by boarding his own Truck bearing NO. JH 10V/2522.

2... That on the same day night around 8.00 P.M the driver of the said Vehicle (Truck No. JH 10V/2522) came to the house of the elder brother of the complainant in very distress condition and stated to the complainant that on the very day about 7.30 A.M. while he was driving the said vehicle and reached near the Namshole Village under Balarampur P.S. under the District - Purulia and within the jurisdiction of this Ld. Court, suddenly a TATA Truck bearing No. WB 55 A / 6756 came in front of the their truck as the driver of Charge the said Vehicle No. WB 55 A/ 6756 lose its control over the same due to his rash and Afficer-in-Olive P. Segligent and very speedy driving. The witness no 3, the driver of the brother of the Balarampur Puruliscomplainant also stated to the complainant and attended to Dist. Puruliacomplanant also stated to the complainant and other witnesses that while he tried his

brother of the complainant was sustained very serious injury in his person due to the said accident and upon seeing the crowed and the condition of his employer he fled away from the spot.

- 3...That upon hearing the incident from the witness No.3 the complainant and his other family members went to the Balarampur P.S. and from there they came to know that his brother was died as his vehicle was met an accident near Namshole, Village under Balarampur P.S. and within the jurisdiction of your honours court.
- 4...That as the brother of the complainant was the only bread earner of the family all the family member were shattered after hearing the news of his demise and they went to their native village at Bihar for the funeral and others ritual after verbal complaint made before the Balarampur P.S.
- 5...That after performing all the ritual of the funeral of his deceased brother when the complainant went to the Balarampur P.S. to lodge complaint about the reason for his brother's death the official of Balarampur P.S. refused to lodge any complaint as there was delay in lodging the F.I.R and make the complainant come to the P.S. day after day on very flimsy ground for refusing to lodge any F.I.R against the driver of the vehicle No. WB 55A/6756 upon whose rash and negligent act the brother of the complainant died.
- 6...That on 12.04.2017 the complainant lodged a written complaint before the S.P. Purulia, stating all material facts and circumstance but till date no action has been taken against the accused person.
- 7...That having no other option left your complainant came before your honour's court with clean hands for necessary action against the accused person responsible for the death of the brother of the complainant.

It is therefore prayed that your honour may graciously be pleased to admit this Misc. Petition and treating the same as a F.I.R. u/s 156(3) of Cr.P.C. be pleased to direct the O.C. Balarampur P.S. to investigate the case as alleged.
