Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that Shri DIBAKAR MUDI S/O LT. SUKU MUDI OF VILL-RAGMA, P.S- BARABAZAR, DIST- PURULIA was enjoying electricity unauthorizedly by direct hooking from nearest LT OH line through Single core copper wire and he has committed theft of electricity U/S 135(1)/a of the electricity (Amendment act-2007).

On 24.05.2018 I, Sri ANSHUMAN MITRA, A.E & S.M., BARABAZAR CCC along with

- (1) Amit Sing, SAE(E), Barabazar CCC, WBSEDCL
- (2) Saheb Sutradhar, SAE(E), Barabazar CCC, WBSEDCL

Entered into the premises of DIBAKAR MUDI S/O LT. SUKU MUDI OF VILL-RAGMA, P.S- BARABAZAR, DIST- PURULIA and inspected his premises at 04:00 p.m.

During inspection, it was found that DIBAKAR MUDI S/O LT. SUKU MUDI OF VILL-RAGMA, P.S- BARABAZAR, DIST- PURULIA was enjoying electricity illegally by direct hooking from nearest LT OH line through Single core copper wire in his premises at Ragma having connected load 0.188 KVA.

From the above arrangement he was using the following equipment:

- 01. 01 no Electric Bulb (100 watt)
- 02. 01 no Electric Bulb (60 watt)

Out of which I seized the following articles:

- 1. 1 no of Single core copper wire (10 mtr. Approx) with hooking device.
- 2. 1 no Electric Bulb (60 watt).

Seizure list was prepared at site and accused person refused to sign. After process of inspection and seizure list we left the premises at about 4:10 p.m.

The said person has committed an offence U/S 135(1)/a of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
