
13. Action taken : Since the above report reveals commission of offence at Jhalda Police Station with Inspector in-charge



Mohanpur, P.S.Kotshila, District Purulia and the present accused persons No.1 and 2 are the residents of village Mosina Mora, P.O.Mosina, P.S.Jhalda, Dist.Purulia(W.B.)

2.----That accused No.1 is the brother-in-law and accused No.2 is the mother-in-law of the complainant.

3.----That on 27-02-2018 corresponding to 14th Falgoon 1424 B.S. at about 4.30 P.M. present complainant went to his father-in-laws house at village Mosina to see his wife ex Smt. Basanti Mura by cycle. When he reached near the house of Mahabir Singh Sardar his son and daughter of the complainant came near him, at that time suddenly accused No.1 to 2 appeared there. Accused Sharu Singh Sardar had Axe and accused No.2 Chaina Singh Sardar had Lathi in their hands. Suddenly accused No.1 Sharu Singh Sardar assaulted the complainant in his head by Axe and accused No.2 Chaina Singh Sardar assaulted the complainant by Lathi with common intention to murder the complainant. Due to the said assault complainant fell down on the ground and sustained bleeding injury on his head and lost his sense, after sometimes, he stands on the grounds and tried to run the Bi-cycle and any how he reached near Jhalda Hat.

Due to heavy bleeding he unable to run the cycle and get down from the cycle and lost his sense. There after he was taken at Kotshila Rural Hospital by his elder brother Barani Mura, witness No.1. Complainant was primarily treated at Kotshila Rural Hospital on 27-02-2018, there after he referred to the Deben Mahato Sadar Hospital Purulia on 28-02-2018. Complainant was
