Apropos above this is to state that demarcation of vested land (Plot No. 8195, 8194, 8193 and 8192 of Mouza Jhalda, J.L. No. 131) was going on today i.e. 11.05.2018 on the direction of the Sub-Divisional Officer, Jhalda. All of a sudden a mob consisting of some female and male headed by Mangal Bagdi s/o Aswini Bagdi, Karam Bagdi s/o Aswini Bagdi and Krishna Rajwar s/o Satrugna Rajwar of Panchamukhi More, Jhalda obstructed the demarcation process without any valid cause and Karam Bagdi s/o Aswini Bagdi of Panchamukhi More, Jhalda without any instigation started to physically assault the undersigned and other Official staff and moreover threatened to slit the throat of the undersigned and other Office staff.

However in the meantime police force reached the spot and rescued us from the place.
