In Producing here with two (02) arrested acced. Persons namely Satrughna Mondal (48) S/O Lt. Srikanta Mondal of Vill. Dibritikar, P.S. Jhalda, Dist. Purulia (ii) Harekrishna Mondal (68) S/O Lt. Kalipada Mondal of Vill- Iloo, P.S. Jhalda, Dist. Purulia brought under arrest with seized article 02(Two) white coloured plastic jar cane containing approx 40 (Forty) Ltrs of I.D Liquor ( 20 liter Each container) from Harekrishna Mondal's house premises. I do hereby lodged this written complain to the effect that on-25/05/2018 at 22:45 hrs during my special raid Duty vide CC No- 1375/18, Dated-25/05/18 I received telephonic source information that one person stocking illegal I.D. Liquor for selling at Iloo village, under Jhalda P.S area in lieu of Money. I inform the matter to I.D. Liquor for selling at Iloo village, under Jhalda P.S area in lieu of Money. I inform the matter to I.C. Jhalda P.S over Phone as per his direction myself along with force left for Village-Iloo, P.S- I/C Jhalda P.S over Phone as per his direction myself along with force left for Village-Iloo, P.S- Jhalda to work out the information. We reached at Iloo Village, at about 00:15 Hours and keep our vehicle on the Road. We proceeded on foot through the open field towards house of Harekrishna Mondal as shown by our source. After about 01 K.M. walking we reached at the house of Hare Krishna Mondal and held raid and found 02(Two) white coloured plastic jar cane containing approx 40 (Forty) Ltrs of I.D Liquor (20 liter Each container) and Seeing police party they started fled away after a small chase we are manage to detain two persons, on being asked they disclosed their identity as noted above. On Interrogation they stated that they jointly sell the I.D. Liquor in lieu of Money for their illegal gain. On demand they failed to produce any valid challan / Papers in respect of I.D. Liquor. Hence they violated the provision of 46 (A) (c) of B.E. Act.

Accordingly I arrested acced. Persons namely Satrughna Mondal (48) S/O Lt. Srikanta Mondal of Vill. Dibritikar, P.S. Jhalda, Dist. Purulia (ii) Harekrishna Mondal (68) S/O Lt. Kalipada Mondal of Vill- Iloo, P.S. Jhalda, Dist. Purulia and prepared arrest memo and seized the 02(Two) white coloured plastic jar cane containing approx 40 (Forty) Ltrs of I.D Liquor( 20 liter Each container) from the house of Harekrishna Mondal , S/O -Lt. Kalipada Mondal of Vill- Iloo, P.S. Jhalda, Dist. Purulia after preparing proper seizure list duly signed by the acced. Persons and prepared proper label for seized articles duly signed by the acced. persons and witnesses. I search for local witnesses but at present found none.

I return to P.S. along with 02 (two) acced. persons and all seized articles. Put the acced. persons in the Lock up after maintaining all formalities and submitted this written complain before you to started a case against two (02) arrested acced. Persons namely (i) Satrughna Mondal (48) S/O Lt. Srikanta Mondal of Vill. Dibritikar, P.S. Jhalda, Dist. Purulia (ii) Harekrishna Mondal (68) S/O Lt. Kalipada Mondal of Vill- Iloo, P.S. Jhalda, Dist. Purulia under proper section of law.
