Road, 5th Floor, Calcutta-700007).

Sir, On 22/04/2018 evening Driver of Truck No. WB-23A/7995 Chetlal Paswan @ Chunnu (15/10/1990) S/o Khagko Paswan of Bandh-Kharo, PS-Suriya, Dist-Giridih, Jharkhand, having Addhar No. 766423113983 and DL No. 0476/08 issued on 21/06/13 of DTO Bokaro, loaded with 602 pieces Asbestos Cement Sheets (Konark) (Total Value-Rs. 261, 498.00/-vide GST Invoice No 9311023684 dated 22/04/18) left from Khargapur UAL Bengal (UAL Industries Ltd) Tungadhowa, Jhargram West Bengal for Kumar Cement Centre, Parga, PS-Joypur, Dist-Purulia and expected delivery date was 23/04/2018, but till date the said consignment not reached at the destination point i.e. Parga under Joypur, Purulia. Several time I tried to contact with my driver over his mobile phone having No. 9083704912, but the same is kept in switch-off mode.

But during my personal enquiry it came out that on till 27/04/18 he was halted at a Road Side Hotel style as "Jungle Hotel" Opposite side of Narayanpur village under PS-Joypur, Dist-Purulia on Purulia-Ranchi Road.

So, it is presume that said driver Chetlal Paswan @ Chunnu fled away with consignment and my truck in an unknown place and by this way he misappropriated with consignment and with me.
