During inspection theft of electricity was detected, that the said present user was enjoying electricity by deenergising the pressure coil of electro magnetic meter by disconnecting of the neutral point of the meter and he was using electrical equipments for carpentary work, water purification, freezing of ice cream and also running domestic appliances. The whole arrangement was made by Iron clad change over switches for committing the said theft.

From the above mentioned unauthorised arrangements he uses the following equipments for commercial uses mainly along with domestic purpose:

- ① Water purification machine. (1.5 KW) : 1 NOS
- ② Water pump (1/2 H.P) : 1 NOS
- ③ Wood cutting machine (0.8 KW) : 1 NOS
- ④ Grinder for carpentary works (0.8 KW) : 1 NOS
- ⑤ Electric fan (80W Each) : 1 NOS
- ⑥ Electric Bulb (100W Each) : 2 NOS
- ⑦ CFL lamp (15W Each) : 4 NOS
- ⑧ Fridge (0.5 KW) : 1 NOS
