At about 12.05 hrs when myself along with force were at P.K Raj High School, and visiting he Booth no 244/134 and 244/135 at that time received telephonic information from CV Lakhikanta Dhibar who is engaged in L/O Duty in C/W Panchayet General Election 2018 at Booth No 244/120 Bodma Pry School Room No 1, that some BJP supporters are obstructing voter at this booth for normal process and also threatened voters to cast vote. Accordingly I informed ASI Indrajit Sarkar who is in Quick response team vide Election CC No 18/18 dt 12.05.18 to go to Bodma and myself along with my team also left for Bodma Pry School (Polling station) about 12.25 hrs myself along with my force and ASI Indrajit Sarkar and his force reached at Booth no 244/120 Bodma Pry School and found that the above noted persons and 100 others BJP supporters with BJP flag obstructing outside the gate of the said school, from our arrival we tried to disperse the BJP supporters/followers but they could not pay any heed to my any instructions moreover they became furious and attacked us with Lathi, Rood, Tangi and also throne stones, brickbats etc aiming towards police personnel. As a result ASI Indrajit Sarkat received grievous head injuries and shoulder injuries and myself also received injuries on my person. Then I informed the matter to my superiors and called HRFS team and RT mobile team for reinforcement. After a while SDPO Raghunathpur came at Bodma village with other officers and force. On seeing more police personnel the BJP supporters fled away from the spot. We tried to apprehend them but could not succeed. After normal lacy, the area we left from Bodma village and ASI indrajit Sarkar and myself took necessary medical treatment at Kolloli Rural Hospital.

On return to P.S I am initiating Kashipir P.S case no 38/18, dt- 14.05.18, U/S - 147/148/149/186/333/355/325/326/307 IPC and SI Abhijit Singha will investigate the case
