The Complainant above named begs to state as follows :-

1. That the Complainant is a resident of Village Gobindapur, P.O. Gobindapur, within P.S. Kenda and under the jurisdiction of this Court.
2. That the property bearing C.S. Plot No.1406 corresponding to R.S. Plot No.1430 recorded in C.S. Khatian No. 65 corresponding to R.S. Plot No.70, are a 27 decimals has been described in the Schedule below.
3. That Hanif Ansari, Karamat Ansari, sons of Late Robi Ansari and Adam Ansari, son of Late Ieman Ali Ansari by virtue of Registered deed of sale dated 20.5.1969 sold the Schedule property in favour of Gobinda Mahato, Khagendra Nath Mahato, Srinibus @ Chinibus Mahato and Haripada Mahato and delivered possession of the same in their favour.
4. That Srinibus @ Chinibus Mahato is alive who is the complainant in this case. Gobinda Mahato died leaving a son Girish Mahato who is Witness No.1. Khagendra Mahato died leaving his widow, Joshada Mahato who is Witness No.2. Haripada Mahato also passed away leaving his widow Bibechana Mahato who is Witness No. 3.

5. That Hanif Ansari and Keramat Ansari also passed away but Adem Ansari, Son of Late Ieman Ansari is alive who is accused person in this case.
  
6. That on 15.2.2018 one namely Hatem Ansari, Son of Late Rustam Ansari came to the Schedule property and he for the first time gave out that the Schedule property Hanif Ansari, Keramat Ansari and Adem Ansary nor they have got right, title, interest and they have/had no saleable right over the Schedule property and in R.S. record stands in the name of other persons, then and there the complainant and other witnesses searched the matter before the B.L.& L.R. Office and has come to learn that the Schedule property Hanif Ansari, Keramat Ansari and Adem Ansary they have fraudulently executed the deed in favour of the complainant and other witnesses. The complainant immediately on 20.2.2018 lodged a diary before the Officer-in-charge Kendap.S. and 7.3.2018 also lodged information before the Superintendent of Police.
  
7. That the accused person intentionally cheated/ deceived the Complainant in respect of the Schedule property and intentionally forged the deed.
  
8. That the accused person cheated the Complainant and forced the papers.
