This is to inform you that myself Arun Mukherjee, S/o Late Balamam Mukherjee, age about 37 years, residing at Near-Layek Pukur, Kulti Smipur Road, PO-Gangulia, PS-Kulti, Dist-Paschim Bardhaman is an employee of authorized IME vendors namely Narula Infrastructure(P) Ltd. of Indus Towers Limited, Saltlake City, Kolkata-700091. We are provide technical and non-technical support to the Indus mobile towers by local man power.

We have a Indus mobile tower bearing Indus Id no:- IN-1063928, situated at perbelia (Near-High School), PO-Neturia, Dist-Purulia under your Police Station area. On 11-05-2018, about 18:00hrs one person namely Md. Manso, S/o Md. Mustaq, residing at Babna Talao, Asansol Railpar, Dist-Paschim Bardhaman entered into our Indus towers site to commit theft in respect Battery and Battery cables etc. of our tower. He was caught red handed with stolen Battery Cables by MTA (Guard) Birendra Mahato and landlord Yogendra Mahato. The miscreant confess his guilt before the public of that area. It may be mentioned that this person was arrested by Kulti P.S. and Barabani P.S. previously for committing such type of crime.

As such I pray necessary action may kindly be taken against him as per law and please investigate.
