With due regards I wish to inform.

Your honour that a gang of miscreants numbering about one hundred entered into the polling station No. NTR-66, Gopalganj Prg. School, Room-1 today at around 3:15 p.m. The on duty police personnel were overpowered and inspite of heart & soul try they could not put a great resistance. The miscreants threatened us and captured the polling station and damaged Ballot Boxes & locked Ballot Boxes and destroyed other polling materials. Then they left the polling station and they set two vehicles on fire bearing Reg. No. WB/82-3576 & JH094-8173.

All the polling party were kept locked inside the polling station. A T.L message was sent to the sector officer & all other concerned informing them regarding this incident.

Later on a team of police personnel rescued us through a back door.

So, I request before your kind self to
take lawfull action.
