Section of Law :-

U/S- 498A/323/34 I.P.Cand 3 and 4 D.P. Act.

Begs to state as follows :-

- 1. That the marriage in between the accused No.1 and the complainant was held on 29th day of Jaistha 1417 B.S. as per Hindu Rites and Customs at Village- Ghagharjuri, p.S.- Purulia(M), which is within the jurisdiction of this Court.
 - 2. That the marriage was a negotiated one and as per demand of the accused persons namely Nepal Paramanik,

 Latika Paramanik, Ranjit Paramanik and Purnima Paramanik

 Rs. 51,000/- (Rupees fifty one thousand) in cash, a cycle,

 3 (three) bhori gold ornaments, Silver tora, Silver chain,

 etc. were given to them.







3. That after marriage the complainant was taken to the house of the accused at Village- Bhagabandh, P.S.-Purulia(M), wherein she started to live with the accused No.1 as husband wife.

It may be stated here that before marriage the accused persons have seen/observed her very well and saw that her great toe of left leg is bend towards left side for which it caused a very little bit inconvenience to walk.

- That after marriage the complainant was well behaved for about one year.
- 5. That due to haddicape of her left leg all the family members of her matrimonial house started to using filthy language as a lame woman and accused No.1 would assault by first and blows and kick and catching her neck and would thrown her out from the house when she would cry.
 - 6. That due to her crying the neighbouring people would reach there and they would save her from the assault. The accuseds would abused in filthy language as the complainant would not be able to carry water by big Gagra or Handi.

It may be stated here that on that day her father -in-law Nepal Paramanik told her father over Phone that contd....P/4.





"you take your daughter from his house otherwise you will see the dead body of your daughter" and her father went to their house.

- 7. That on that day the accused Nos. 1 and 2, 3, 4 and 5 demanded further No. 25,000/- for the business purpose of accused No.1 from her father or to take his daughter otherwise they will murder her and will buried her dead body.
 - 8. That thereafter the father of the complainant was compelled to take her to his house at Village- Ghagharjuri.
 - 9. That even after such torture the poor father of the complainant took her to her matrimonial house but they would not provide her proper food and would compell her to do every house hold works still then they would assault her by fist and belows, kick and lathi without any rhyme or reason and drove her out from their house.
 - 10. That in the year 2016 on 26th Jaistha a complain was lodged at Purulia(M) P.S. when the o.C. got the dispute compromised and again the complainant used to go their house at Village-Bhagabandh.
 - 11. That on 22/12/2016 due to pain of appendics the complainant was admitted in Purulia Hospital and the appendics was operated but none of them came to see her though number of occassion information was given.

- Paramanik daughter of Anadi Paramanik of Village- Shiyal-danga of Santuri P.S. and all other accuseds arranged for the second marriage of accused No.1 and got the same performed which took place last Agrahayan, thereafter tried to live with the accuseds but they refused.
 - 13. That all the accuseds have committed offence of bride torture, assault, demand of further dowry and big any for which all the accuseds be published according to Law.
 - 14. That the information was lodged at Purulia (M)
 P.S. and thereafter to S.P. Purulia but the Police has
 taken no step for which the petition is filed before
 the Ld. Court.

It is, therefore, prayed that your Honour be graciously pleased to pass an order to send this petition to O.C. Purulia(M) P.S. with a direction to investigate the facts of the case treating this petition as F.I.R. and to submit report before the Ld. Court.
