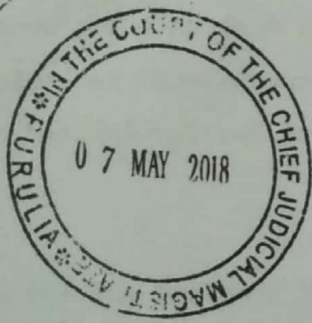

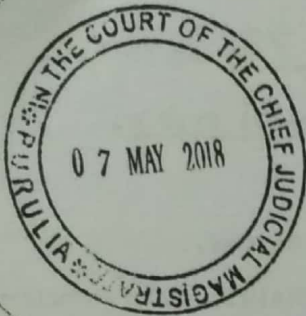
1.... That on the date of occurrence i.e. on 2.3.2018 at about 5 P.M. the accused persons armed with Rod and farsa all on a sudden came to the house of the complainant and attacked her with an intention to murder her for previous grudge.

2...That accd. No. 2 assaulted the complainant on her head over the ear with a rod in order to murder her. As a result the complainant fell down on the ground and at that time Accused No. 3 caught hold her throat and pressed her chest and accused No. 1 assaulted her with the handle of the farsha.

3...That the complainant started shouting and any how escaped the hands of Chapala from her throat. ^{Hearing} ~~Hearing~~ the shouting the witness No. 1 came to the spot and ^{witnessed -} ~~intend~~ the incident. She requested the accused persons not to assault her she also told her not to murder her. But they did not pay heed to her words and accused No. 2 assaulted said witness No. 2 Bharati Goswami with a rod.

4... That hearing her shouting the witness Nos. 3,4,5 along with many other villagers came to the spot and saved ^{her} and admitted the complainant at Purulia Sadar Hospital for treatment and she was discharged from Hospital on ~~4~~. 4.3.2018.

5... That out of fear and due to her treatment the complainant could not inform the matter earlier. He informed the matter in writing to the Police of Purulia



Purulia (M) P.S. on 6.3.18. But the Police for the reason best known to them did not take any step against the accused persons.

6...That under this situation then again on 22.3.18 at about 10/11 P.M. when ^{the complainant} ~~she~~ was going to bath room, ^{the Accd.} ~~she~~ entered into ^{the room of complainant} ~~her~~ room and put cloths in ^{her} ~~my~~ month and threatened the complainant that he would commit rape upon her. He also threatened her that the Police could not do anything and he also threatened that if the complainant disclosed the matter to any body would be murdered. Presently the complainant and her son are in her paternal house out of fear and threat of the accused persons.

7...That under this circumstances the complainant informed the matter to the S.P. Purulia ~~but~~ in vain.

8...That your petitioner is ~~not~~ an poor and woman she has no capacity to pull the expenditure ~~of~~ ~~the~~ complainant oriented case. Moreover there are technical matter, like search and seizure which are not possible in a complainant oriented case.

So the Police case is desirous.

Under the circumstances it is prayed that your Honour may be graciously pleased to send this complainant petition to the Police of Purulia (M)P.S. and pass necessary order directing the Police to investigate case treating it as F.I.R.
