Sub: - FIR against Sri Dipak Kumar Kuiry

In reference to the above, it is mention that Sri Dipak Kumar Kuiry S/o Sri Haren Chandra Kuiry of Village Bhul, Panchayet Dimdiha, Purulia-I Block, after getting work order from this office for construction of "Low cost onion storage", applied for payment for that structure with a false photograph of the scheme. Later before visit of the Field Consultant of that block, he very temporarily erected a structure not at all complying the Govt. Guidelines. On 19.04.2018 the undersigned visited the scheme site, but no trace of that structure was noticed.

Hence, it revealed that Sri Kuiry misguided the Office to misuse Govt. Money (Subsidy for that scheme of Rs 87500.00) intentionally.

Therefore, you are requested to treat this letter as an FIR against Sri Kuiry U/S 420 of the IPC and to take necessary legal steps against him as applicable.
