I SI, Dipanakar Sarkar, O/C Purulia (T) PS do hereby lodged complaint Suo-motu against arrested accused persons (1) Nepal Ch Mardana (32 yrs) s/o Anil Kr Mardana of Bhatbandh, Purulia (2) Krishnendu Chatterjee (27 yrs) s/o Lt Dipendu Shekhar Chatterjee of Amdiha (3) Khokan Modak (20 yrs) s/o Lt Sunil Modak of Katinpara, (4) Sanjib Sen @ Buro (39 yrs) s/o Lt Jagabandhu Sen of Bhatbandh (5) Mongal Nandi (36 yrs) s/o Lt Sanatan Nandi of Telkal para (Lohar para) (6) Jatla Orang (22 yrs) s/o Lt Jatan Orang Bhatbandh Kamar para, all under Purulia (T) PS, (7) Biswanath Mahato (28 yrs) s/o Dasharath Mahato of Maguria, PS- Purulia (M) and absconding accused (1) Suraj Sharma of Muchi Para, Purulia (2) Babu Kumar of Ketika, Purulia (3) Pintu Bauri of Sadhudanga, Purulia (4) Usha Ojha of Karpur bagan (5) Subrata Bauri of Tikiapara (6) Tushar Awasthi of Old Police Line, Purulia, (7) Bishnu Bauri of Kadam kuli and unknown 250/300 unruly mob of Bajrang Dal & BJP to the fact that today (22.05.2018) at 09:35 hrs during performing duty at Sadar Court Purulia, observed that above persons with approx 250/300 people gathered at the premises of Sadar Court Purulia to attend the bail hearing of one Gourab Singh, a District leader of Bajrang Dal, Purulia, who was arrested in c/w Purulia (T) PS Case No 38/2018. They were discussing that, said Gourab Singh with Suraj Sharma of Muchi Para, Purulia & Nepal Ch Mardana of Bhatbandh, Purulia, all of Bajrang Dal have asked them to gather at that place to raise slogan so that Ld Court could be compelled to grant bail of said Gourab Singh; if bail is not granted by the Court, they will rampage throughout Purulia town area. Some Superior officers of Purulia Police were present with police team. After few minutes, when they came to know that, the bail petition of said Gourab Singh has been rejected by the Ld Court, then they became violent and shouting slogan "SOB BHENGE DE, GUNRIYE DE" they proceeded towards Purulia bus stand area. We followed them and coming to Purulia Bus stand found that, they were forcing bus-workers as well as general passengers not to run buses and not to move. They also damaged fruit trolleys at random. We tried to pacify them, but assaulting us they proceeded their unlawful rally. Finding no other way we declared the mob as unlawful assembly and directed them to disperse. But the mob became furious and overpowering us they rampaged throughout the Purulia town area to endanger public safety & tranquility. They terrorized all shop keepers at Purulia bus stand, hospital morh, taxi stand, hat tola morh, Nadiha etc area to keep close their shops instantly by shouting "SALA EKHON I DOKAN BANDHO KAR, GOURABER JAMIN NA HOUA OBDI BANDHO RAKHBI, JODI TAR AGE KHULIS DOKAN BHENGE GUNRIYE DEBO!!" and on way they damaged many morh fruit-trolleys. Then they reached at Nadiha Misti Mahal and blocked the NH 18 using Govt Guard-Rails of Police and disrupted vehicular movement. They also damaged all the Govt Guard-Rails placed at the same. All of us again tried to pacify them and asked them to withdraw the blockade onNH, but they did not pay any heed to my word and the mob became more furious and started to abuse police in filthy language and stated "POLICE KE MERE FEL" and started rampant brick batting with a view to kill police. 04 police personnel became injured by their pelted stone. Finding no other alternative, we chased them and managed to apprehend above noted 07 arrested persons when others fled away. At the time of apprehension they stated that, under the direct instigation of said Gourab Singh, Suraj Sharma & Nepal Ch Mardana they set out for violence. We arranged to admit our injured police personnel at Purulia Sadar Hospital, where 02 are admitted in serious condition.

Some leader of the unruly mob managed to escape away. They were identified as (1) Suraj Sharma of Muchi Para, Purulia (2) Babu Kumar of Ketika, Purulia (3) Pintu Bauri of Sadhudanga, Purulia (4) Usha Ojha of Karpur bagan (5) Subrata Bauri of Tikiapara (6) Tushar Awasthi of Old Police Line, Purulia, (7) Bishnu Bauri of Kadam kuli. Huge nos. of brick bats, Lathi, were seized from the P.O. Damaged trolleys of fruits were also seized. After sometimes unruly mob was dispersed and situation became under control.
