Sir,

I Sri Kapil Lath son of Sri Arun Kumar Lath, age about 34 years, presently residing at Prabhu Niketan, South Lake Road, B1 Lake View Apartment, Post & P.S. & District Purulia.

Begs to inform you that my father has Landed Property in Purulia Town, Chaibasa Road near Usha machine, in holding No.37, recorded in R.S. Khata No.3392, being R.S Plot No.7389.

I am looking after the aforesaid property on behalf of my father & I have been instructed by my father to construct a building over the aforesaid property after demolishing the old construction & after demolishing the said construction while raising the new construction on 13/05/16 around 3.00 Pm, the persons namely:-

1. Ashok Bhagat, son of Bholanath Bhagat, age about 58 years resident of Raghabpur More, near forest office, Tulsi Apartment, P.O. & P.S. & Dist. Purulia.

2. Rakesh Bhagat, son of Bholanath Bhagat, age about 45 years resident of Rathtalla More, New Colony, Post & P.S. & Dist Purulia.

3. Pradip Bahgat, son of Bhalanath Bhagat, age about 52 years resident of Raghabpur More, near forest office, Tulsi Apartment, P.O. & P.S. & Dist. Purulia.

Along with other people Raised objection without any reason in my construction work, using slang languages, trespass in my property, and Rakesh Bhagat was in drunken position holding iron rod broke a portion of my boundary wall and all together threatened me saying if I proceed with the construction work anymore he will murder me and also stopped the workers working there & accordingly I have informed the entire matter before the Purulia Bar Association in writing & the Secretary & other Lawyers instructed me to give information before the Police so that I will get legal help from you as well as from the Purulia Bar.

Being from well-known family and a lawyer by profession, I thought to settle the matter peacefully but the above named people are so adamant that they did not pay heed to my words. Under the aforesaid circumstances, I am feeling risk of my life and further, I am apprehending that aforesaid persons may again come back and do anything to stop my construction work. The workers are also afraid to do work. Day by day I am bearing a huge loss by paying house rent and material cost and which cannot be compensate in terms of money.

Lastly, finding no other way I request you after submitting me my application you will take immediate steps against the aforesaid persons, who are ready to commit serious breach of peace over the property described herein before and obliged one.

Please treat the same as urgent.
