I Sri Prashant Kishor, S/O - Kishori Prasad, A.E. & Station Manager of Telkalpara CCC of WBSEDCL do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Joytirmay Bhattacharjee S/O Niranjan Prasad Bhattacharjee of Vill - Raghampur, PS-Purulia(M) has committed theft of electricity under section 135(1)(b) as detailed here under.

Today, i.e. on 11.05.2018 I, Prashant Kishor (AE&SM), along with Sri Chinmoy Maity, SAE(E), & Sri Debdulal Banerjee, Sr.TSH of Telkalpara CCC, WBSEDCL conducted a raid programme at village Raghampur under Purulia(M) P.S. When our team at about 01.00 P.M. entered to the Domestic premises of Jyotirmoy Bhattacharjee, we found that he was enjoying electricity dishonestly by means of bypassing the energy meter by way of tampering incoming of meter and run domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, disconnected service line along with dismantled bypass meter and seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 01.30 P.M. after completion of inspection & necessary formalities.

Joytirmay Bhattacharjee S/O Niranjan Prasad Bhattacharjee of Vill - Raghampur, PS-Purulia(M) has committed theft of electricity under section 135(1)(b) of the Electricity (Amendment) Act-2007.
