I requested them to calm down as final tally has not come yet .But they did not pay any heed to my words and snatched one of the signed certificate which was being prepared for other winning candidates and at the time of snatching of Form 24 ( Certificate of Election ) they ill behaved with me as well as tortured me physically .

Now keeping in mind , I would request you to lodge an FIR in this regard and to take necessary action as soon as possible .
