The complainant most respectfully begs to state :-

1. That both the complainant and accused person are the permanent inhabitants of Ward No.3 of Raghunathpur Municipality, P.O. Raghunathpur, District-Purulia and very familiar and known to each other.
2. That one day on 15.03.2013 in the morning accused Randulal Deogheria came to the residence of the complainant and disclosed and declared himself as an agent of Financial Institution in the name and style "Akin Project Limited Company" and explained some attractive beneficial scheme of the company.
3. That being influenced by the version of the accd. persons and reposed confidence upon the statement of the accd. person, the complainant agreed to invest money with the above stated Institution of the accused persons.

Ranikhetpur (Purulia)

4. That there after the accused person requested the complainant time and again to pay him the money.
5. That the complainant paid/delivered an amount of Rs. 50,000/- in cash on 19.3.2013 to the accused person in presence of the witnesses towards the scheme or the company, in which the amount will be one and half times within three year from the date of the investment i.e. on and from 19.3.2013.
6. That on the very date of investment the accd. person delivered the certificate and Receipt of the Company relating to the above stated investment "In the style Letter of Allotment". The xerox copy of the said certificate and the receipt is attached with this complain petition.
7. That the above stated investment made by company got its maturity on 19.9.2016 valued at Rs. 75,000/-.
8. That after the maturity the complainant made contact with the accused person several times for getting the above stated matured value, but on each and every occasion the accused person deferred the matter on one pretext or the other which creates room for suspicion in the mind of the complainant.

9. That being giving by above stated suspicion the complainant started searching about the tangibility existence and viability of the above stated company

and came to learn that the company is a fictitious and fake one, which has got no recognition and is valid one.

10. That it is evident that the accused person practiced deception fraudulently upon the complainant as a result of which the complainant paid money amounting to Rs. 50,000/- to the accused person and the receipt and certificate granted by the accused person to the complainant are nothing but manufactured and forged.

11. That by the above stated manner the accused person has also misappropriated the amount of Rs. 50,000/- for his wrongful gain.

12. That it is evident from the above stated facts and circumstances the accused person has committed offence u/s 406/420 I.P.C.

13. That it is to be submitted that till this day the accused person has not paid single furthing to the complainant

so the complainant lodge the complaint before the O/C Raghunathpur P.S. on 13/11/2017 ^{through Post} and while O/C

Raghunathpur P.S. took no action the complainant lodged
