I, SI Mahadeb Rana of Santuri PS returned to PS along with force and submitted a suomoto against 1) Mufti @ Abdul Gaffar of Murulia, 2) Laltu @ Aniruddha Goswami S/O- Sri Haradhan Goswami of Santuri, 3) Sk. Haidu of Murulia, 4) Lakhikanta Dhibar of Muradi, 5) Jagabandhu Bouri of Balitora, 6) Parthasarathi Shantikari S/O-Lt. Badal Shantikari of Talberia, 7) Satyajit @ Bumba Banerjee of Kinaidih, 8) Akshay Chatterjee S/O-Lt. Tarapada Chatterjee of Ramchandrapur, 9) Anjan Goswai of Namokotaldi, 10) Manas Mukherjee of Namokotaldi, 11) Swapan Gorain @ Huna of Hansdima, 12) Kashinath Sutradhar of Brindabanpur, 13) Biswajit Paramanik of Brindabanpur, 14) Subhajit Mondal of Brindabanpur, 15) Bimal Kaibartya of Brindabanpur and 200/250 other unknowns supporters of BJP to the effect that in course of my D/P duty. I received a telephonic information that supporters of BJP had blocked the State Highway (running between Raghunathpur & Saltora through Santuri PS) near Santuri PS. Accordingly, I reached at the spot and found that the above mentioned supporters of BJP along with 200/250 unknown supporters had blocked the said road near the PS from 18:30 hrs to 21:25 without paying any heed to the order of us to clear the road blockade and cause no disturbance to the Passengers and riders Vehicles and passersby & without considering about the sufferings of the passenger of the trucks and other vehicles etc and the other passersby. Then, they took entered into the PS premises and created obstruction in PS work. I got the photos and video recording also.

Under the above circumstances and fact, I therefore pray that a cog. case may kindly be started U/S 143/341/186/188/283/506 IPC and section 18 of The W.B Highways Act. 1964 (Act 28 of 1964) against the above mentioned accused persons and arrange for its investigation.
