In producing here with two arrested accused persons namely 1) Santosh Prasad (36 Yrs) S/O Damodar Prasad of Upper Beniasole, Adra, PS- Adra Dist- Purulia 2) Dipak Sahu (38 Yrs) S/O Doman Sahu of Vill- Bankradanga PS- Adra Dist- Purulia along with following seized articles viz-

- 1) 21 bottles (in sealed condition) CAPTAIN 60 up country spirit, 600-ml each bottle and value-Rs-75 of each Bottle
- 2) 10 bottles (in sealed condition) DIL SE 80 up country spirit, 600-ml each bottle and value-Rs-35 of each bottle.
- 3) 05 Empty bottle of DIL SE 80 up country spirit, 600-ml
- 4) Sale proceed of Rs.- 190/- (One hundred ninety rupees only)

I SI Bibekananda Ganguly Adra P.S. do here by lodged a complaint against accused persons namely 1) Santosh Prasad (36 Yrs) S/O Damodar Prasad of Upper Beniasole, Adra, PS- Adra Dist- Purulia 2) Dipak Sahu (38 Yrs) S/O Doman Sahu of Vill- Bankradanga PS- Adra Dist- Purulia to the effect that on 15.06.18 at about 18:15 hrs. in course of my evening mobile duty I received a telephonic information from a reliable source that one Santosh Prasad (36 Yrs) S/O Damodar Prasad of Upper Beniasole, Adra, PS- Adra Dist- Purulia & Dipak Sahu (38 Yrs) S/O Doman Sahu of Vill- Bankradanga PS- Adra Dist- Purulia was stocked country spirit illegally and selling the same to hike price for their personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with C/23 Chandi Mukherjee & C/669 Subrata Sarkar rushed to the spot for raid by Govt. vehicle. At about 18:45 hrs. myself along with force reached at Adra - Kashipur Bus Stand near Deshbandhu Club and hold raid in the Jhupri of Santosh Prasad found that said Santosh Prasad & Dipak Sahu stocked liquor at their own Jhupri and selling the same to the consumers. Seeing the Police party some persons including Santosh Prasad & Dipak Sahu tried to flew away but however after a small chase we were able to apprehend Santosh Prasad & Dipak Sahu. I asked Santosh Prasad & Dipak Sahu to produced valid License or valid papers of selling liquor but they failed to produced any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused persons informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accused persons and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accused persons namely 1) Santosh Prasad (36 Yrs) S/O Damodar Prasad of Upper Beniasole, Adra, PS- Adra Dist- Purulia 2) Dipak Sahu (38 Yrs) S/O Doman Sahu of Vill- Bankradanga PS- Adra Dist- Purulia and arrange for its investigation.
