In producing here with one arrested accused person namely Nitesh Kr. Yadav (28 Yrs.) S/O Bijoy Yadav of Kamalasthan, Adra, PS- Adra Dist- Purulia along with following seized articles viz-

- ) 32 bottles (in sealed condition) DIL SE 80 up country spirit, 600-ml each bottle and value-Rs-35 of each bottle.
- ) Sale proceed of Rs.- 435/-
- ) Ten pieces of plastic glass.

I ASI Giridhari Roy Adra P.S. do here by lodged a complaint against Nitesh Kr. Yadav (28 Yrs.) S/O Bijoy Yadav of Kamalasthan, Adra, PS- Adra Dist- Purulia to the effect that on 17.06.18 at about 16:15 hrs in course of my evening mobile duty I received a telephonic information from a reliable source that one Nitesh Kr. Yadav (28 Yrs.) S/O Bijoy Yadav of Kamalasthan, Adra, PS- Adra Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with C/41 Dinesh Bouri & C/Suresh Dutta rushed to the spot for raid by Govt. vehicle. At about 16:35 hrs. myself along with force reached at Kamalasthan and hold raid in the Jhupri ( Kamasthan) of Nitesh Kr. Yadav found that said Nitesh Kr. Yadav sealing liquor at his own Jhupri and seeing the Police party some person fled away and said Nitesh Kr. Yadav to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly signed by accused person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accused person namely Nitesh Kr. Yadav (28 Yrs.) S/O Bijoy Yadav of Kamalasthan, Adra, PS- Adra Dist- Purulia and arrange for its investigation.
