- 3) Ten pieces of plastic glass.


I SI Parikshit Mahato Adra P.S. do here by lodged a complaint against accd. namely Madhu Hela (40 yrs.) S/O Parma Hela of Lower Jhariadh PS- Adra Dist- Purulia to the effect that on 05.06.18 at about 16:45 hrs in course of my evening mobile duty I received a telephonic information from a reliable source that one Madhu Hela (40 yrs.) S/O Parma Hela of Lower Jhariadh PS- Adra Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with C/669 Subrata Sarkar & C/677 Sayad Julhar Ali rushed to the spot for raid by Govt. vehicle. At about 17:15 hrs. myself along with force reached at Lower Jharidh and hold raid in the Jhupri (Near SBI Arrah) of Madhu Hela found that said Madhu Hela liquor at his own Jhupri and seeing the police party some person fled away and said Madhu Hela to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd. person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accd. Madhu Hela (40 yrs.) S/O Parma Hela of Lower Jhariadh PS- Adra Dist- Purulia and arrange for its investigation.
