In producing here with one arrested accd. namely Rajib Mukhi (30 Yrs.) S/O Anand Mukhi of Sevanagar PS- Adra Dist- Purulia along with following seized articles viz-

- 1) 32 bottles (in sealed condition) DIL KHUS 80 up country spirit, 600-ml each bottle and value-Rs-35 of each bottle.
- 2) Sale proceed of Rs.- 70/-
- 3) Eight pieces of plastic glass.

I SI Parikshit Mahato Adra P.S. do here by lodged a complaint against accd. namely Rajib Mukhi (30 Yrs.) S/O Anand Mukhi of Sevanagar PS- Adra Dist- Purulia to the effect that on 05.06.18 at about 19:35 hrs in course of my evening mobile duty I received a telephonic information from a reliable source that one Rajib Mukhi (30 Yrs.) S/O Anand Mukhi of Sevanagar PS- Adra Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with C/669 Subrata Sarkar & C/677 Sayad Julhar Ali rushed to the spot for raid by Govt. vehicle. At about 19:55 hrs. myself along with force reached at Sevanagar and hold raid in the Jhupri (at Sevanagar) of Rajib Mukhi found that said Rajib Mukhi liquor at his own Jhupri and seeing the police party some person fled away and said Rajib Mukhi to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing /selling the same. So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd. person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accd. Rajib Mukhi (30 Yrs.) S/O Anand Mukhi of Sevanagar PS- Adra Dist- Purulia and arrange for its investigation.
